**SPECIAL PROVISIONS**

The bid award shall be based on the availability of funds.

**Bidder Qualifications**

Bidder shall be compliant through Hawaii Compliance Express (HCE) pursuant to Chapter 103D, Hawaii Revised Statutes. Vendors/contractors/service providers should register with HCE prior to submitting an offer at <https://vendors.ehawaii.gov>. The annual registration fee is \$12.00 and the "Certificate of Vendor Compliance" is accepted for the execution of contract and final payment. Vendors/contractors/service providers are advised to register on HCE soon as possible. If a vendor/contractor/service provider is not compliant on HCE at the time of award, the Bidder will not receive the award.

**Bid Quotation**

Bid price shall include all requested materials, shipping and transportation, all applicable taxes, and any other costs incurred to provide materials as specified herein. The total bid quotation shall be based upon the information as specified in Attachment 2.

**CAMPAIGN CONTRIBUTIONS**

**CAMPAIGN CONTRIBUTIONS BY STATE AND COUNTY CONTRACTORS PROHIBITED** If awarded a contract in response to this solicitation, Contractor agrees to comply with HRS §11-355, which states that campaign contributions are prohibited from a State and county government contractor during the term of the contract if the contractor is paid with funds appropriated by the legislative body between the execution of the contract through the completion of the contract.

## **INDEMNIFICATION**
