6. **QUESTION:** Confirming it is the intent of the BO1331-53 specifications to include all PA and Visual PA equipment associated with the new Terminal 1 Lobby 3 Security Checkpoint?

RESPONSE: Yes, it is the intention to have the maintenance contract include all PA and Visual PA equipment associated with the new Terminal 1 Lobby 3 Security Checkpoint.

7. **QUESTION:** Regarding specification section 2.7 Disqualification of Bidders, which says, any of the following reasons may be considered as being sufficient grounds for the disqualification of a bidder and the rejection of his proposal or proposals. A. More than one proposal for the same work from an individual, firm, or corporation under the same or different name. B. Evidence of collusion among bidders. Can a specification required vendor be a subcontractor on another contractor's bid proposal and provide a bid proposal as Prime contractor to increase chances of winning the bid? Additionally, can a prime contractor's bid proposal?
