Do not include confidential and/or proprietary documents with the proposal. The record of each bidder and respective bid shall be open to public inspection. <u>FAILURE TO</u> <u>UPLOAD THE PROPOSAL TO HIEPRO SHALL BE GROUND FOR REJECTION</u> OF THE BID.**

SPECIAL PROVISIONS

These specifications contained herein are amended as follows:

- A. <u>SECTION 1 DEFINITION AND TERMS</u> shall be amended as follows:
 - 1. <u>1.33 SUBCONTRACTOR</u> shall be amended in its entirety to read as follows:

"<u>1.33 SUBCONTRACTOR</u> – An individual, partnership, firm, corporation, or joint venture, or other legal entity, as licensed or required to be licensed under Chapter 444, Hawaii Revised Statutes, as amended, which enters into an agreement with the Contractor to perform a portion of the work."

2. <u>1.38 WORKING DAY</u> shall be amended in its entirety to read as follows:

"<u>1.38 WORKING DAY</u> – Every day, except Saturdays, Sundays, and State holidays as applicable and as observed.

Normal State holidays are as follows:

New Year's Day (The first day of January) Dr. Martin Luther King, Jr. Day (The third Monday in January) President's Day (The third Monday in February) Prince Jonah Kuhio Kalanianaole Day (The twenty-sixth day in March) Good Friday (The Friday preceding Easter Sunday) Memorial Day (The last Monday in May) King Kamehameha I Day (The eleventh day in June) Independence Day (The fourth day in July) Statehood Day (The third Friday in August) Labor Day (The first Monday in September) General Election Day (The first Tuesday in November following the first Monday of even numbered years) Veteran's Day (The eleventh day in November) Thanksgiving (The fourth Thursday in November) Christmas (The twenty-fifth day in December)

3. Add the following new subsection:

"<u>1.39 HAWAII ePROCUREMENT SYSTEM (HIePRO)</u> - The State of Hawaii eProcurement System for issuing solicitations, receiving proposals and responses, and issuing notices of award. <u>1.40 ENGINEER</u> – The respective District Engineer, acting directly or through their duly authorized representatives, who are responsible for District engineering supervision of construction and other highway matters.

<u>1.41 STANDARD SPECIFICATIONS</u> – The Hawaii Standard Specifications for Road and Bridge Construction, 2005, Highways Division, Department of Transportation, including any amendments. Log on to:

The Contractor shall utilize the latest revision.

B. <u>SECTION 2 – PROPOSAL REQUIREMENTS AND CONDITIONS</u> shall be amended as follows:

1. <u>2.3 DELIVERY OF PROPOSALS</u> is amended by replacing the entire subsection with:

"2.3 DELIVERY OF PROPOSALS – Bidders shall submit and <u>upload the</u> <u>complete proposal to HIePRO</u> prior to the bid opening date and time. Proposals received after said due date and time shall not be considered. Original (wet ink, hard copy) proposal documents are not required to be submitted. Contract award shall be based on evaluation of proposals submitted and uploaded to HIePRO. Any additional support documents explicitly designated as <u>confidential and/or proprietary</u> shall be uploaded as a <u>separate file</u> to HIePRO. Do not include confidential and/or proprietary documents with the proposal. The record of each bidder and respective bid shall be open to public inspection.

FAILURE TO UPLOAD THE COMPLETE PROPOSAL TO HIEPRO SHALL BE GROUNDS FOR REJECTION OF THE BID.

If there is a conflict between the specification document and the HIePRO solicitation, the specifications shall govern and control, unless otherwise specified."

2. <u>2.4 WITHDRAWAL OF PROPOSALS</u> shall be amended by replacing the entire subsection with:

"<u>2.4 WITHDRAWAL OF PROPOSALS</u> – A bidder may withdraw or revise a proposal after the bidder submits the proposal in HIePRO. Withdrawal or revision of proposal must be completed before the time set for receiving of bids."

- 3. <u>2.5 PUBLIC OPENING OF PROPOSALS</u> is not applicable.
- 4. <u>2.8 OUT OF STATE BIDDERS</u> shall be amended by adding the following to the end of the subsection:

"Successful out-of-state bidders shall, after ten (10) days from the Notice to Proceed, provide a name and phone number of the Contractor's Technical Representative who will be responsible in assisting the recipient districts throughout the duration of the contract. Corporations must be registered to do business in the State of Hawaii. For information on business registration, please call Department of Commerce and Consumer Affairs at (808) 586-2545 or log on to: http://www.hawaii.gov/dcca/areas/breg.

C. <u>SECTION 3 – AWARD AND EXECUTION OF CONTRACT</u> shall be amended as follows:

1. <u>3.1 AWARD OF CONTRACT</u> shall be amended by adding the following to the end of the subsection:

"The State reserves the right to reject any and all proposal and to waive any defects as may be deemed to be in the best interest of the public. Any bid lacking a unit price or amount shall disqualify the bidder."

- D. <u>SECTION 4 SCOPE OF WORK</u> shall be amended as follows:
 - 1. <u>4.6 VARIATION IN QUANTITY</u> shall be replaced in its entirety to read as follows:

"<u>4.6 CONTRACT TO BE INDEFINITE QUANTITY</u> – The requirement for materials to be furnished by the Contractor will be on an "as-needed" basis as called for in these Specifications at the applicable unit price bid during the term of this contract and in such numbers as may be required by the State. The quantities specified in the contract is an estimate and does not signify a minimum or maximum amount. The unit bid price indicated by the Contractor shall be applicable and binding under the terms of this contract. Payment for services will be made by Purchase Order."

E. <u>SECTION 6 – CONTROL OF MATERIALS AND EQUIPMENT</u> shall be amended as follows:

6.2 TRADE NAMES AND ALTERNATES is amened as follows:

1. The first paragraph of A. QUALIFICATION BEFORE BID OPENING shall be replaced with the following:

"A. QUALIFICATION BEFORE BID OPENING - When the specifications and/or plans specify one or more manufacturer's brand names of materials or equipment to indicate a quality, style, appearance, or performance, the bidder will be assumed to have based its bid on one of the specified named products, except where such proprietary product are specified, alternate brands may be qualified if found equal or better by the Department. The bidder shall submit a request to the Department for review and approval at the earliest date possible. Requests shall be submitted via email to the Contact person listed in HIePRO for the solicitation and also posted as a question in HIePRO under the question/answer tab referencing the email with the request. The request must be posted in HIePRO no later than fourteen (14) calendar days before the bid opening date." 2. The first sentence of the second paragraph of A. QUALIFICATION BEFORE BID OPENING shall be replaced with the following:

"It shall be the responsibility of the bidder to submit sufficient evidence based upon which a determination can be made by the Department that the alternate brand is a qualified equivalent"

- F. <u>SECTION 8 PROSECUTION AND PROGRESS</u> shall be amended as follows:
 - 1. <u>8.1 PROGRESS OF WORK</u> shall be amended by adding the following paragraph to the end of the subsection:

"The Contractor shall diligently prosecute the work to completion within the time limit specified in the proposal. The Notice to Proceed will indicate the date the Contractor is expected to begin the work and from which date contract time will be charged. The Contractor shall give his personal attention to the fulfillment of the contract and shall keep the work under his control.

If the materials fail to meet specification requirements, the Contractor will be notified of such and the material will be rejected. The Contractor shall replace the rejected material with those that meet the specification requirements, and liquidated damages in accordance with the 8.2 Liquidated Damages of the Special Provisions, will be assessed against him for late delivery any time after the required completion date. Time taken to perform the material sampling and testing, however, will not be charged against the Contractor."

- 2. <u>8.2 LIQUIDATED DAMAGES</u> shall be amended by as follows:
 - a. Add the following to the end of the subsection:

"1/4 of 1% of the total contract price of each item for each calendar day for failure to deliver the items within the delivery period. The assessed amount, however, will be no less than TEN DOLLARS (\$10.00) for each bid item for each and every calendar day."

b. The following shall replace the first sentence of the second paragraph:

"Delivery extension shall be considered only with written notice **prior to delivery deadline**. Written notice requesting extension will not be considered without a copy of the factory order, factory confirmation of order and without documents substantiating that the cause(s) for delay is, in fact, beyond the control of the Contractor. The State shall be the sole judge of whether such delay is truly beyond the control of the Contractor and whether an extension will be granted."

G. <u>SECTION 9 – PAYMENT</u> shall be amended as follows:

1. <u>9.2 PROGRESS PAYMENTS</u> shall be amended by adding the following to the end of the subsection:

"D. Deductions, as applicable, shall be included in the invoices as subtotal(s) and labeled as either (1) and/or (2) below:

- (1) Retainage as specified in Section 9.2 Progress Payments, of the Specifications.
- (2) Liquidated Damages, as specified in Section 8.2 of the Special Provisions.

After the delivery of materials, the Contractor shall forward the required invoice as specified in Section 9.2 Progress Payments, of the Specifications, to the recipient district as applicable and as indicated below for approval of payments.

The Engineer shall issue a Purchase Order for payments to pay for all furnished, delivered, and accepted materials.

Pursuant to the State of Hawaii Department of Transportation (DOT) Procurement Delegation signed by the DOT Director on October 8, 2012, Purchase Orders may not be issued or used unless there is a Purchase Requisition signed by an authorized person."

SECTION 1 - DEFINITION AND TERMS

Whenever the following pronouns are used in these specifications, or in any documents or instruments where these specifications govern, the intent and meaning shall be interpreted as follows:

<u>1.1 ADDENDA</u> - A written document which may be issued by the Director during the bidding period involving changes to the specifications and plans, if any, which shall be considered and made a part of the contract.

<u>1.2 AIRPORTS DIVISION</u> - Airports Division, Department of Transportation, State of Hawaii.

 $\underline{1.3}$ \underline{AWARD} - The written acceptance of a proposal by the State.

<u>1.4 BIDDER</u> - Any individual, partnership, corporation or other legal entity, or combination thereof, submitting a proposal for the work contemplated, acting either directly or through a duly authorized representative.

<u>1.5 CALENDAR DAY</u> - Every day shown on the calendar. If no designation of calendar or working day is made, "day" shall mean calendar day.

<u>1.6 CHANGE ORDER</u> - A written order issued by the Director to the Contractor requiring the contract work to be performed in accordance with a change or changes that may involve an adjustment in contract time and price or requiring performance of any unforeseen work essential to complete the contract.

<u>1.7 CONTRACT</u> - The written agreement between the State and the Contractor setting forth the obligations of the parties thereunder, including, but not limited to, the performance of the work, the furnishing of labor and materials, and the basis of payment.

The contract includes the (1) notice to bidders, (2) proposal, (3) contract form and contract bond, (4) specifications, (5) special provisions and plans, if any, (6) addenda, (7) notice to proceed, and (8) change orders and agreements that are required to complete the work, all of which constitute one instrument.

<u>1.8 CONTRACT BOND</u> - The approved form of security, executed by the Contractor and its Surety or Sureties, guaranteeing the completion of the work in accordance with the terms of the contract, and guaranteeing full payment of all claims for labor, materials, and supplies used or incorporated in the work. <u>1.9 CONTRACT TIME</u> - The number of working days or calendar days allowed for completion of the contract, including authorized time extensions.

If a calendar date is specified as the date of completion in lieu of the number of working days or calendar days, the contract shall be completed by that date.

In case the contract is for a specified period of time, the contract time shall be for said specified period of time.

<u>1.10 CONTRACTOR</u> - The individual, partnership, corporation or other legal entity, or combination thereof, contracting with the State for performance of the prescribed work.

<u>1.11 DEPARTMENT</u> - The State Department of Transportation.

 $\underline{1.12}$ DIRECTOR - The Director of Transportation, acting either directly or through the Director's duly authorized representative.

<u>1.13 EQUAL OR APPROVED EQUAL</u> - Whenever this term is used in the specifications and plans, if any, it means a brand or article pre-qualified in accordance with Section 6.2 <u>Trade</u> <u>Names and Alternates</u> and which may be used in place of the one specified.

<u>1.14 H.A.R. or HAR</u> - Hawaii Administrative Rules.

<u>1.15 H.R.S. or HRS</u> - Hawaii Revised Statutes.

<u>1.16 HARBORS DIVISION</u> - Harbors Division, Department of Transportation, State of Hawaii.

<u>1.17 HIGHWAYS DIVISION</u> - Highways Division, Department of Transportation, State of Hawaii.

<u>1.18 HOLIDAYS</u> - The days which are set apart and established as State holidays pursuant to Section 8-1, H.R.S.

<u>1.19 INSPECTOR</u> - The Director's authorized representative assigned to make detailed inspections of contract performance and materials supplied.

<u>1.20 NOTICE TO BIDDERS</u> - The public announcement, as required by law, inviting proposals for the work to be performed or materials to be furnished.

<u>1.21</u> NOTICE OF FINAL ACCEPTANCE - Written notice from the Director to the Contractor that the entire contract has been completed in all respects in accordance with the specifications and plans, if any, and any changes thereof previously approved by the Director.

<u>1.22</u> NOTICE TO PROCEED - Written notice from the Director to the Contractor advising the Contractor of the date on which he is to begin the prosecution of the work.

<u>1.23 PLANS</u> - The contract drawings approved by the Director which show the location, character, dimensions and details of the work to be done and shall be a part of the contract.

<u>1.24 PROCUREMENT OFFICER</u> - The Director's duly authorized representative including project managers, project engineers and contract administrators assigned to prepare, evaluate and administer contracts for the purchasing of goods and services.

<u>1.25 PROPOSAL (OR BID)</u> - The offer of a bidder, on the prescribed form, to perform the work and to furnish the labor and materials at the prices quoted.

<u>1.26 PROPOSAL FORM</u> - The approved format prepared by the Department or a facsimile thereof on which bids for the work must be prepared and submitted. (Reasonable facsimile acceptable for bidding.)

<u>1.27 PROPOSAL GUARANTY</u> - The security furnished with a proposal to guarantee that the bidder will enter into the contract and furnish all other requirements if the bidder's proposal is accepted.

<u>1.28 QUALIFICATION QUESTIONNAIRE</u> - The specified forms on which the bidder shall furnish required information as to the bidder's ability to perform and finance the work.

<u>1.29 S.L.H. or SLH</u> - Session Laws of Hawaii.

<u>1.30 SPECIAL PROVISIONS</u> - Revisions to the specifications. The specific clauses setting forth conditions or requirements peculiar to the project under consideration which are not thoroughly or satisfactorily stipulated in these specifications.

<u>1.31</u> SPECIFICATIONS - The directions, provisions, and requirements pertaining to the method and manner of performing the work and to the quantities and qualities of materials to be furnished under the contract.

<u>1.32 STATE</u> - The State of Hawaii.

<u>1.33</u> SUBCONTRACTOR - An individual, partnership, corporation, other legal entity, or any combination thereof, that enters into an agreement with the Contractor to perform a portion of the work for the Contractor.

<u>1.34</u> <u>SUPERINTENDENT</u> - The Contractor's representative who is responsible for and in charge of the work.

<u>1.35</u> SURETY - The corporation, partnership or individual, other than the Contractor, executing a bond furnished by the Contractor and guaranteeing performance by the Contractor.

<u>1.36 TITLES (OR HEADINGS)</u> - The titles or headings of the Sections herein are intended for convenience of reference and shall not be considered as having any bearing on their interpretation. Unless otherwise indicated, whenever the word "Section" is used, reference is being made to a Section in these specifications.

<u>1.37 WORK</u> - The furnishing of all labor, materials, equipment, and other incidentals necessary or convenient for the successful completion of the project and the execution of all the duties and obligations imposed by the contract.

<u>1.38 WORKING DAY</u> - Any day, except Saturdays, Sundays and State holidays.

SECTION 2 - PROPOSAL REQUIREMENTS AND CONDITIONS

2.1 PROPOSAL FORMS - All proposals shall be made on forms furnished by the Department. All proposals shall give the prices proposed in the spaces provided and shall be signed by the bidder, who shall fill out all blanks in the proposal form as therein required.

2.2 REJECTION OF PROPOSALS CONTAINING ALTERATIONS, ERASURES, <u>OR IRREGULARITIES</u> - Proposals may be rejected if they show any alterations of form, additions not called for, conditional bids, incomplete bids, erasures, or irregularities of any kind.

When proposals are signed by any agent, other than the officer or officers of a corporation authorized to sign contract on its behalf or a member of copartnership, a Power of Attorney must be on file with the Department prior to opening bids or shall be submitted with the proposal; otherwise, the proposal may be rejected as irregular and unauthorized.

Members of a joint venture may be requested to supply the Department with a copy of their joint venture agreement or each member of the joint venture may be required to sign the proposal.

2.3 DELIVERY OF PROPOSALS - Each proposal shall be placed, together with the proposal guaranty, when required, in an envelope and sealed and so marked as to indicate the identity of the project, the name and address of the bidder, and other required information and then delivered as indicated in the Notice to Bidders. Proposals will be received up to the time fixed in the Notice to Bidders for the opening of bids.

2.4 WITHDRAWAL OF PROPOSALS - Any proposal may be withdrawn at any time prior to the time fixed in the Notice to Bidders for the opening of proposals upon the filing of a written request therefor with the Department, executed by the bidder or his duly authorized representative. The withdrawal of a proposal shall not preclude a bidder from submitting a new proposal.

2.5 PUBLIC OPENING OF PROPOSALS - Proposals will be opened and read publicly at the time and place indicated in the Notice to Bidders. Bidders or their authorized agents are invited to be present.

<u>2.6 DISQUALIFICATION OF BIDDERS</u> - Any of the following reasons may be considered as being sufficient grounds for the disqualification of a bidder and the rejection of his proposal or proposals.

A. More than one proposal for the same work from an individual, firm, or corporation under the same or different name.

B. Evidence of collusion among bidders. Participants in such collusion will receive no recognition as bidders for any future work of the Department until such participant shall have been reinstated as a qualified bidder.

C. Evidence of assistance from a person who has been an employee of the agency within the preceding two years and who participated while in State office or employment in the matter with which the contract is directly concerned, pursuant to Section 84-15, HRS.

D. Lack of proposal guaranty.

E. Unsigned proposal or proposal not signed in ink by person or persons legally authorized to submit a proposal on behalf of the bidder.

2.7 MATERIAL GUARANTY - The bidder may be required to furnish a complete statement of the origin, composition and manufacture of any or all materials to be used in the prosecution of the work, together with samples. Such samples may be subjected to tests to determine their quality and fitness for the work.

2.8 OUT-OF-STATE BIDDERS - Pursuant to Section 103D-1008, Hawaii Revised Statutes, on out-of-state purchases where the bidder or vendor is an out-of-state vendor, not doing business in the State, the bid price of such out-of-state vendor, for the purpose of determining the lowest price bid, shall be increased by the applicable retail rate of general excise tax and the applicable use tax. The lowest responsible bidder, taking into consideration the above increases, shall be awarded the contract, but the contract amount of any contract awarded shall be the amount of the bid offered and shall not include the amount of said increases.

Such increases will not be applied in case an out-ofstate vendor specifies in its bid that its bid price includes said general excise tax; the bidder will be required to pay said general excise tax and use tax in case the bidder is awarded the contract.

2.9 TAX REQUIREMENTS - Work to be done under this contract is a taxable transaction and the bidder receiving the award for this work will be required to pay the State of Hawaii General Excise Tax (GET) and the State of Hawaii use Tax.

<u>3.1 AWARD OF CONTRACT</u> - The State reserves the right to reject any and all proposals and to waive any defects as may be deemed to be in the best interest of the public.

The award of contract, if it be awarded, will be made within sixty (60) calendar days after the opening of bids to the lowest responsive and responsible bidder whose proposal complies with all the prescribed requirements. The successful bidder will be notified, by letter mailed to the address shown on its proposal, that its proposal has been accepted and it has been awarded the contract.

Requirement for award. To be eligible for award, the apparent low Bidder will be contacted to submit copies of the documents listed below to demonstrate compliance with Section 103D-310(c), HRS. The documents should be submitted to the Department as soon as possible. If a valid certificate/clearance is not submitted on a timely basis for award of a contract, a Bidder otherwise responsive and responsible may not receive the award.

A. Tax Clearance.

Pursuant to §103D-310(c), 103-53 and 103D-328, HRS, the successful bidder shall be required to submit a certified copy of its tax clearance issued by the Hawaii State Department of Taxation (DOTAX) and the Internal Revenue Service (IRS) to demonstrate its compliance with Chapter 237, HRS. Pursuant to §103D-310(c), HRS, the successful bidder shall be required to submit a copy (faxed copies are acceptable) of its approved Certificate of Compliance issued by the Hawaii State Department of Labor and Industrial Relations (DLIR) to demonstrate its compliance with unemployment insurance (Chapter 383, HRS), workers' compensation (Chapter 386, HRS), temporary disability insurance (Chapter 392, HRS), and prepaid health care (Chapter 393, HRS). The certificate is valid for six (6) months from the most recent approval stamp date on the certificate and must be valid on the bid's first legal advertisement date or any date thereafter up to the bid opening date. For certificates which receive a "pending" approval stamp, a DLIR approval stamp is required prior to the issuance of the Notice to Proceed.

The application for the Certificate of Compliance is the responsibility of the bidder, and must be submitted directly to the DLIR. The approved certificate may then be submitted to the Department.

C. DCCA Certificate of Good Standing.

Pursuant to §103D-310(c), HRS, the successful bidder shall be required to submit a copy (faxed copies are acceptable) of its approved Certificate of Good Standing issued by the Hawaii State Department of Commerce and Consumer Affairs (DCCA), Business Registration Division (BREG) to demonstrate that it is either:

- incorporated or organized under the laws of the State; or
- (2) registered to do business in the State as a separate branch or division that is

capable of fully performing under the contract.

A Certificate of Good Standing is valid for six (6) months from the approval date on the certificate and must be valid on the bid's first legal advertisement date or any date thereafter up to the bid opening date. A Hawaii business that is a sole proprietorship, is not required to register with the BREG, and therefore not required to submit a Certificate of Good Standing. Bidders are advised that there are costs associated with registering and obtaining a Certificate of Good Standing from the DCCA.

The application for the Certificate of Good Standing is the responsibility of the bidder, and must be submitted directly to the DCCA. The approved certificate may then be submitted to the Department.

<u>3.2</u> CANCELLATION OF AWARD - The State reserves the right to cancel the award of any contract any time before the execution of said contract by all parties without any liability to the successful bidder or any other bidder.

<u>3.3 EXECUTION OF CONTRACT</u> - The contract shall be executed by the successful bidder and returned, together with the contract bonds, when required, within ten (10) days after the award of the contract or within such further time as the Director may allow after the bidder has received the contract for execution.

Pursuant to Section 103D-309, H.R.S., the contract shall not bind the State in any way unless said contract has been fully and properly executed by all the parties thereto and the Comptroller has endorsed thereon a certificate that there is available an unexpended appropriation over and above all outstanding contracts, sufficient to cover the amount required by the contract.

<u>3.4 FAILURE TO EXECUTE CONTRACT</u> - Failure to execute the contract and file acceptable bonds, when required, within ten (10) days after the award of the contract, or within such further time as the Director may allow, shall be cause for the cancellation of the award and the forfeiture of the proposal guaranty. Award of the contract may then be made to the next lowest responsible bidder.

<u>4.1 WORK TO BE DONE</u> - The work to be done is described in the Section(s) following Section 9 of these specifications.

<u>4.2 PERFORMANCE OF WORK</u> - The Contractor shall employ, so far as possible, such methods and means in carrying out his work so as not to cause any interruption, disturbance, or interference with the public.

In case the Contractor is performing work in a building, the Contractor shall conduct the work in such a manner so as not to cause any interruption, disturbance, or interference with the business activities of the tenants in the building.

<u>4.3 EXTRA WORK</u> - New and unforeseen items of work will be classed as extra work when they cannot be covered by any of the various items for which there is a bid price.

4.4 CHANGES AND CLAIMS FOR ADJUSTMENT

A. <u>Change order</u>. By a written order, at any time, and without notice to any surety, the procurement officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- Drawings, designs, or specifications, if the goods to be furnished are to be specially manufactured for the State in accordance therewith;
- 2. Method of shipment or packing;
- 3. Place of delivery;
- 4. Changes in the work within the scope of the contract; or
- 5. Changes in the time of performance of the contract that do not alter the scope of work.

Β. Adjustments of price or time for performance. If any change order increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the price adjustment clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the procurement officer promptly and duly make the provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have

prejudiced any claim for additional compensation, or an extension of time for completion.

C. <u>Time period for claim.</u> Within thirty (30) days after receipt of a written change order under subsection (a) unless the period is extended by the procurement officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State or county is prejudiced by the delay in notification.

D. <u>Claim barred after final payment</u>. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.

E. <u>Other claims not barred.</u> In the absence of a change order, nothing in this clause shall be deemed to restrict the contractor's right to pursue a claim as under the contract or for breach of contract.

4.5 PRICE ADJUSTMENT

Any adjustment in contract price pursuant to a clause in this contract shall be made in one or more of the following ways:

A. By agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;

B. By unit prices specified in the contract or subsequently agreed upon;

C. By the costs attributable to the event or situation covered by the clause, plus appropriate profit or fee, all as specified in the contract or subsequently agreed upon;

D. In such other manner as the parties may mutually agree; or

E. In the absence of agreement between the parties, by a unilateral determination by the procurement officer of the costs attributable to the event or situation covered by the clause, plus appropriate profit or fee, all as computed by the procurement officer in accordance with generally accepted accounting principles and applicable sections of chapters 3-123 and 3-126 of the Hawaii Administrative Rules.

4.6 VARIATION IN QUANTITY

Upon agreement of the parties, the quantity of goods or services or both specified in this contract may be increased by a maximum of ten (10) percent provided (1) the unit prices will remain the same except for any price adjustments otherwise applicable and (2) the procurement officer makes a written determination that such an increase will either be more economical than awarding another contract or that it would not be practical to award another contract.

SECTION 5 - CONTROL OF WORK

<u>5.1 AUTHORITY OF DIRECTOR</u> - The Director shall decide all questions which may arise as to the quality or acceptability of materials furnished and work performed, the manner of performance and rate of progress of the work, and compensation for work performed, interpretation of the contract and fulfillment of the contract on the part of the Contractor. The Director shall have authority to enforce and make effective such decisions and orders which the Contractor fails to carry out properly and diligently. The decision of the Director shall be final.

5.2 COORDINATION OF PLANS, SPECIFICATIONS AND SPECIAL <u>PROVISIONS</u> - These specifications, plans, special provisions, and all supplementary documents are essential parts of the contract, and a requirement occurring in one is as binding as though occurring in all. They are intended to be complementary and to describe and provide for a complete work.

<u>5.3 CLAIMS AND DISPUTES</u> - The Contractor may give notice in writing to the procurement officer for claims that extra compensation, damages, or an extension of time for completion is due the Contractor for one or more of the following reasons:

A. Requirements not clearly covered in the contract, or not ordered by the procurement officer as an extra work;

B. Failure between the State and the Contractor to agree to an adjustment in price for a contract change order issued by the State; or

C. An action or omission on the part of the procurement officer requiring performance changes within the scope of the contract.

The Contractor shall continue with performance of the contract in compliance with the directions or orders of the procurement officer, but by so doing, the Contractor shall not be deemed to have prejudiced any claim for additional compensation, damages, or an extension of time for completion; provided:

A. The notice in writing be given:

1. Before the commencement of the work involved, if at that time the Contractor knows of such requirements or the occurrence of such actions or omissions; or

2. Within thirty (30) calendar days after the

Contractor knows of such requirements or the occurrence of such action or omission if the Contractor did not have such knowledge before the commencement of the work; or

3. Within thirty (30) calendar days after receipt of the written contract change order that was not agreed upon by both parties; or

4. Within such further time as may be allowed by the procurement officer in writing.

B. The notice shall clearly state the Contractor's intention to make claim and the reasons why the Contractor believes that additional compensation, changes or an extension of time may be remedies to which the Contractor is entitled; and afford the procurement officer every facility for keeping records of the actual cost of work. Failure on the part of the Contractor to give such notification or to afford the procurement officer proper facilities for keeping strict account of actual cost shall constitute waiver of the claim for such extra compensation. The filing of such notice by the Contractor and the keeping of costs by the procurement officer shall not in any way be construed to prove the validity of the claim.

The procurement officer will review the notice and render a decision. The procurement officer's decision shall be final and conclusive unless, within thirty (30) calendar days from the date of the decision, the Contractor mails or otherwise furnishes a written appeal to the Director. The decision of the Director shall be final. Later notification of such claims shall not bar the Contractor's claim unless the State is prejudiced by the delay in notification. No claim by the Contractor for an adjustment hereunder shall be allowed if notice is not given before final payment under this contract. Any adjustment in the contract price made pursuant to this clause shall be determined according to Section 4.5 - Price Adjustment.

The provisions of this Section shall not be construed as establishing any claims contrary to the terms of Section 4.4 - Changes and Claims for Adjustment.

Nothing herein contained, however, shall excuse the Contractor from compliance with any rules of law precluding any state officers and any Contractors from acting in collusion or bad faith in issuing or performing contract change orders which are clearly not within the scope of the contract.

SECTION 6 - CONTROL OF MATERIAL AND EQUIPMENT

<u>6.1 DEFECTIVE MATERIALS</u> - All materials not conforming to the requirements of these specifications or the special provisions shall be considered defective and all such materials, whether in place or not, shall be rejected. They shall be removed immediately from the site of the work, unless otherwise permitted by the Director. No rejected materials, the defects of which have been subsequently corrected, shall be used until approval in writing has been given by the Director. Upon failure on the part of the Contractor to comply promptly with any order to remove and replace defective materials, the Director may remove and replace defective material and to deduct the cost of removal and replacement from any monies due or to become due the Contractor.

<u>6.2 TRADE NAMES AND ALTERNATES</u> - For convenience in designation on the plans or in the specifications, certain equipment or articles or materials may be designated under a trade name or the name of a manufacturer and its information catalogue. The use of alternate equipment or an article or material which is of equal quality and of the required characteristics for the purposes intended will be permitted, subject to the written approval of the Director, in accordance with the following requirements:

QUALIFICATION BEFORE BID OPENING - When the Α. specifications and/or plans specify one or more manufacturer's brand names of materials or equipment to indicate a quality, style, appearance, or performance, the bidder will be assumed to have based its bid on one of the specified named products, except where such proprietary product are specified, alternate brands may be qualified if found equal or better by the Director. Bidders requesting gualification of alternate proprietary products must submit a request to the Director for review and approval at the earliest date possible, but in any event, such request must be received at the Contracts office not later than ten (10) days before the bid opening date, not including the bid opening date.

It shall be the responsibility of the bidder to submit sufficient evidence based upon which a determination can be made by the Director that the alternate brand is qualified. The evidence shall be transmitted with a covering letter which shall list the evidence submitted and the items for which the substitution is requested.

If the evidence accompanying a request for substitution is insufficient to qualify a particular

model, the request shall be denied provided that further evidence may be submitted to qualify the item five (5) days prior to the bid opening date if the initial request was made prior to the deadline set above.

B. <u>SUBSTITUTION AFTER BID OPENING</u> - Substitution of material or equipment will not be allowed after the bid opening date except under the following unforeseen circumstances:

1. If a specified or pre qualified item is delayed by a lengthy strike in the factory or other unforeseeable contingency beyond the control of the Contractor which would cause an abnormal delay in the project completion.

2. If a specified or pre qualified item is found to be unusable due to change or other circumstances.

3. If the Contractor is willing to provide a more recently developed or manufactured item of material or equipment of the same manufacturer which the Director determines to be equal or better than the one specified or pre-qualified.

A substitution request, regardless of reason, shall be fully explained in writing by the Contractor and shall include its justification for said request, the quantities and unit prices involved, quotations and such other documents as are deemed necessary to support the request. Any savings in cost will accrue to the State and any additional cost for the substituted items will be paid by the Contractor.

The burden of proof as to the comparative quality and suitability of alternate equipment, articles, or materials shall be upon the bidder or Contractor and bidder or Contractor shall furnish, at its own expense, all information necessary or related thereto as required by the Director. The Director shall be the sole judge as to the comparative quality and suitability of alternate equipment, articles or materials and the Director's decisions shall be final.

The above shall not be construed to mean that substitution for brand name specified materials and equipment will be allowed; the Director reserves the right to deny any request he deems irregular or not in the best interest of the State.

6.3 ASSIGNMENT OF ANTITRUST CLAIMS FOR OVERCHARGES FOR GOODS AND MATERIALS PURCHASED

A. Vendor and purchaser recognize that in actual economic practice, overcharges resulting from antitrust violations are in fact usually borne by the purchaser. Therefore, vendor hereby assigns to purchaser any and all claims for such overcharges as to goods and materials purchased in connection with this order or contract, except as to overcharges which result from antitrust violations commencing after the price is established under this order or contract and which are not passed on to the purchaser under an escalation clause.

B. Contractor and owner recognize that in actual economic practice, overcharges resulting from antitrust violations are in fact usually borne by the owner. Therefore, contractor hereby assigns to owner any and all claims for such overcharges as to goods and materials purchased in connection with this order or contract, except as to overcharges which result from antitrust violations commencing after the price is established under this order or contract and any change order. In addition, contractor warrants and represents that each of its first tier suppliers and subcontractors shall assign any and all such claims to owner, subject to the aforementioned exception.

SECTION 7 - LEGAL RELATIONS AND RESPONSIBILITY

7.1 LAWS TO BE OBSERVED - The Contractor shall comply with all federal, state, city and county laws, ordinances, rules and regulations which in any manner affect those engaged or employed in the work, the materials used in the work, and the conduct of the work. Any reference to such laws, ordinances, rules and regulations shall include any amendments thereto effective as of the date of the call for sealed proposals.

The Contractor shall hold harmless, indemnify, defend and where appropriate, insure the State, its officers, agents and employees against any claim or liability arising from or based on the violation of any such laws, ordinances, rules or regulations. If any discrepancy or inconsistency is discovered in the contract for the work in relation to any law, ordinance, rule, regulation, order or decree, the Contractor shall forthwith report the same to the Director in writing.

7.2 PERMITS AND LICENSES - The Contractor shall procure all permits and licenses, pay all charges and fees, and give all notices necessary and incident to the due and lawful prosecution of the work.

7.3 PATENTS - The Contractor shall assume all costs arising from the use of patented materials, equipment, devices, or processes used on or incorporated in the work, and shall hold harmless, indemnify, defend and where appropriate, insure the State, its officers, agents and employees from all suits at law or actions of every nature, for or on account of the use of any patented materials, equipment, devices or processes.

7.4 RESPONSIBILITY FOR INJURY AND DAMAGE - The State, its officers, agents and employees shall not be held accountable in any manner for any loss or damage to the work or any part thereof, or for any of the materials and equipment used or employed in performing the work, or for any injury to any person or persons either workers or the public, or for any damage to property caused by the Contractor or its workers or any one employed by the Contractor. The Contractor shall be responsible for any liability imposed by law for any injury to any person or any damage to property resulting from defects or obstructions or from any cause whatsoever during the progress of the work or at any time before its completion and final acceptance. The acceptance of the completed work of the Contractor by the Director shall not relieve the Contractor from any liability which may have accrued or may accrue as a result of the performance of the work by the Contractor. The Contractor shall hold harmless, indemnify, defend and where appropriate, insure the State, its officers, agents and employees, from all suits or actions of every name, kind and description, brought for or on account of

any injuries or damages sustained by any persons or property caused by the Contractor, its servants or agents, or by or on account of any act or omission of the Contractor or its servants or agents, regardless of whether such actions or any claim is brought against them or any one of them before or after the final acceptance of the work. In addition to any remedy authorized by law, the State may withhold payment of any money due to Contractor as shall be reasonable until disposition has been made of any suits or claims for injuries or damages.

It is not the intention of the parties to this contract to make the public or any member thereof a third party beneficiary hereunder, or to authorize anyone not a party hereto to maintain a suit for personal injuries or property damage based on a contract theory of liability. In any event, the Contractor shall hold harmless, indemnify, defend and where appropriate, insure the State from suits and claims for personal injuries or property damage where such injuries or damage are caused by the negligent acts or omissions of the Contractor, its agents or employees.

7.5 COOPERATION BETWEEN CONTRACTORS - Where two or more Contractors are employed on related or adjacent work, each shall conduct its operations in such a manner as not to cause any unnecessary delay or hindrance to the other.

7.6 CONTRACTOR'S RESPONSIBILITY FOR WORK - Until the acceptance of the contract, the Contractor shall have the charge and care thereof and shall bear the risk of injury or damage to any part thereof by the action of the elements or from any other cause, whether arising from the execution or from the non-execution of the work. The Contractor shall rebuild, repair, restore, and make good all damages to any portion of the work occasioned by any of the above causes before its completion and acceptance and shall bear the expenses thereof.

7.7 NO PERSONAL LIABILITY - Neither the Director nor any other officer or authorized employee of the Department shall be personally responsible for any liability arising under the contract.

7.8 INSURANCE - Prior to commencing with the work, the Contractor shall, at its own expense, obtain and submit to the Department, Certificate of Insurance from an insurance company authorized by the laws of the State to issue such insurance in the State of Hawaii showing full policy coverage of the Contractor.

TYPES OF INSURANCE:

A. Workers' Compensation:

The Contractor shall obtain worker's compensation insurance for all persons whom they employ in carrying out the work under this contract. This insurance shall be in strict conformity with the requirements of the most current and applicable State of Hawaii Worker's Compensation Insurance laws in effect on the date of the execution of this contract and as modified during the duration of the contract. The minimum limit of liability for workers compensation is the HRS 386 statutory limit.

B. Comprehensive Automobile Liability:

The Contractor shall obtain Auto Liability Insurance covering all owned, non-owned and hired autos with a combined single Limit of not less than \$1,000,000 per accident for bodily injury and property damage with the State of Hawaii named as additional insured. The required limit of insurance may be provided by a single policy or with a combination of primary and excess policies.

C. Commercial General Liability:

The Contractor shall obtain General Liability insurance with a limit of not less than \$1,000,000 per occurrence and in the aggregates. The General liability insurance shall include the State of Hawaii as an additional insured. The required limit of insurance may be provided by a single policy or with a combination of primary and excess policies.

All policies must provide that 30 days prior written notice of cancellation or material change in coverage be given to certificate holders stated above.

Such insurance when accepted by the Director in writing shall become applicable and shall remain unmodified throughout the entire term of the contract and in no event shall be terminated or otherwise allowed to lapse prior to written certification of final acceptance of the work by the State. Such insurance aforementioned shall cover the State for all work performed under the contract, all work performed incidental thereto or directly or indirectly connected therewith, including other work performed outside of the work area, and all change orders. Any delay in the submission and approval of insurance certificates shall not be justification of or grounds for a request by the Contractor postponing the issuance of a notice to proceed notwithstanding the fact that the Contractor shall not be allowed to proceed with the work until said certificates are submitted and approved.

Failure to obtain insurance in accordance with the Section, on the part of the Contractor, shall be considered a major breach of the contract; and should the State be forced to expend funds which would have been covered under the insurance, the Contractor agrees to assume the liability for such funds and to indemnify and hold the State harmless.

SECTION 8 - PROSECUTION AND PROGRESS

<u>8.1 PROGRESS OF WORK</u> - The Contractor shall diligently prosecute the work to completion within the time limit specified in the proposal. The Contractor shall give its personal attention to the fulfillment of the contract and shall keep the work under its control. Work shall commence on the date indicated in the "Notice to Proceed" letter from the State.

<u>8.2 LIQUIDATED DAMAGES</u> - Time is of the essence in this contract and in case the Contractor fails to complete the work within the time specified in the proposal, damages will be sustained by the State. Since the amount of damages is difficult and not possible of definite ascertainment and proof, the amount of such damages are fixed in advance at the sum shown in the proposal for each and every calendar (or working) day which the Contractor has delayed in the completion of this contract; and the Contractor shall pay such amount as liquidated damages, and not by way of penalty, and in case the same are not paid, the State may deduct such amount thereof from any monies due or that may become due the Contractor under this contract.

If the Contractor finds it impossible for reasons beyond its control to complete the work within the contract time as specified, the Contractor shall, within 10 days from the first day of notification from the manufacturer or supplier of any delay and prior to the expiration of the contract time, make a written request to the Director for an extension of time setting forth therein the reasons which the Contractor believes will justify the granting of its request.

The Contractor's plea that insufficient time was specified is not a valid reason for extension of time. If the Director finds that the work was delayed because of conditions beyond the control and without the fault of the Contractor, the Director may extend the time for completion in such extension as the conditions justify. The extended time for completion shall then be in full force and effect the same as though it were the original time for completion.

8.3 TEMPORARY SUSPENSION OF WORK

A. Order to stop work. The Director, may, by written order to the contractor, at any time, and without notice to any surety, require the contractor to stop all or any part of the work called for by this contract. This order shall be for a specified period not exceeding sixty (60) days after the order is delivered to the contractor, unless the parties agree to any further period. Any such order shall be identified specifically as a stop work order issued pursuant to this section. Upon receipt of such an order, the contractor shall forthwith comply with its terms and take all reasonable steps to minimize the occurrence of costs allocable to the work covered by the order during the period of work stoppage. Before the stop work order expires, or within any further period to which the parties shall have agreed, the Director shall either:

1. Cancel the stop work order; or

2. Terminate the work covered by such order as provided in the "termination for default clause" or the "termination for convenience clause" of this contract.

B. <u>Cancellation or expiration of the order</u>. If a stop work order issued under this section is canceled or if the period of the order or any extension thereof expires, the contractor shall have the right to resume work. An appropriate adjustment shall be made in the delivery schedule or contract price, or both, and the contract shall be modified in writing accordingly; if:

1. The stop work order results in an increase in the time required for, or in the contractor's cost properly allocable to, the performance of any part of this contract; and

2. The contractor asserts a claim for such an adjustment within thirty (30) days after the end of the period of work stoppage; provided that, if the Director decides that the facts justify such action, any such claim asserted may be received and acted upon at any time prior to final payment under this contract.

C. <u>Termination of stopped work.</u> If a stop work order is not canceled and the work covered by such order is terminated for default or convenience, the reasonable costs resulting from the stop work order shall be allowable by adjustment or otherwise.

D. <u>Adjustment of price</u>. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the price adjustment clause of this contract.

8.4 DEFAULT AND TERMINATION OF CONTRACT

A. <u>Termination by Default.</u> If the contractor refuses or fails to perform any of the provisions of this contract with such diligence as will ensure its completion within the time specified in this contract, or any extension thereof, otherwise fails to timely satisfy the contract provisions, or commits any other substantial breach of this contract, the Director may notify the contractor in writing of the delay or nonperformance and if not cured in ten (10) days or any longer time specified in writing by the Director, such officer may terminate the contractor's right to proceed with the contract or such part of the contract as to which there has been delay or a failure to properly perform. In the event of termination in whole or in part the Director may procure similar goods or services in the manner and upon terms deemed appropriate by the Director. The contractor shall continue performance of the contract to the extent it is not terminated and shall be liable for excess costs incurred in procuring similar goods or services.

1. <u>Contractor's duties.</u> Notwithstanding termination of the contract and subject to any directions from the Director, the contractor shall take timely, reasonable, and necessary action to protect and preserve property in the possession of the contractor in which the State or county has an interest.

2. <u>Compensation</u>. Payment for completed goods delivered and accepted by the State shall be at the contract price. Payment for the protection and preservation of property shall be in an amount agreed upon by the contractor and Director; if the parties fail to agree, the Director shall set an amount subject to the contractor's rights under chapter 3-126, HAR. The State may withhold from amounts due the contractor such sums as the Director deems to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders and to reimburse the State for the excess costs incurred in procuring similar goods and services.

Excuse for nonperformance or delayed 3. performance. Except with respect to defaults of subcontractors, the contractor shall not be in default by reason of any failure in performance of this contract in accordance with its terms, including any failure by the contractor to make progress in the prosecution of the work hereunder which endangers such performance, if the contractor has notified the Director within fifteen (15) days after the cause of the delay and the failure arises out of causes such as: acts of God; acts of the public enemy; acts of the State and any other governmental body in its sovereign or contractual capacity; fires; floods; epidemics; guarantine restrictions; strikes or other labor disputes; freight embargoes; or unusually severe weather. Ιf the failure to perform is caused by the failure of a subcontractor to perform or to make progress, and if such failure arises out of causes similar to those set forth above, the contractor shall not be

deemed to be in default, unless the goods or services to be furnished by the subcontractor were unreasonably obtained from other sources in sufficient time to permit the contractor to meet the contract requirements. Upon request of the contractor, the Director shall ascertain the facts and extent of such failure, and if such officer determines that any failure to perform was occasioned by any one or more of the excusable causes, and that, but for the excusable cause, the contractor's progress and performance would have met the terms of the contract, the delivery schedule shall be revised accordingly, subject to the rights of the State under the clause entitled "Termination for Convenience". As used in this paragraph of this clause, the term "subcontractor" means subcontractor at any tier.

4. <u>Erroneous termination for default.</u> If, after notice of termination of the contractor's right to proceed under the provisions of this clause, it is determined for any reason that the contractor was not in default under the provisions of the clause, or that the delay was excusable under the provisions of paragraph (3), Excuse for nonperformance or delayed performance of this clause, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the notice of termination had been issued pursuant to such clause.

5. <u>Additional rights and remedies.</u> The rights and remedies provided in this clause are in addition to any other rights and remedies provided by law or under this contract.

B. <u>Termination for convenience</u>. The Director may, when the interests of the State so require, terminate this contract in whole or in part, for the convenience of the State. The Director shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective.

1. <u>Contractor's obligation</u>. The contractor shall incur no further obligations in connection with the terminated work and on the dates set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Director may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the State. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

2. <u>Right to goods</u>. The Director may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the procurement officer:

a. Any completed goods; and

b. The partially completed goods and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights hereinafter called "manufacturing material," as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract.

The contractor shall, upon direction of the Director, protect and preserve property in the possession of the contractor in which the State has an interest. If the Director does not exercise this right, the contractor shall use the contractor's best efforts to sell such goods and manufacturing materials. Use of this section in no way implies that the State has breached the contract by exercise of the termination for convenience clause.

3. <u>Compensation:</u>

a. The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data to the extent required by subchapter 15, chapter 3-122, HAR, bearing on such claim. If the contractor fails to file a termination claim within one (1) year from the effective date of termination, the Director may pay the contractor, if at all, an amount set in accordance with subparagraph c. below.

b. The Director and the contractor may agree to settlement provided the contractor has filed a termination claim supported by cost or pricing data to the extent required by subchapter 15, chapter 3-122, HAR, and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of goods and manufacturing materials under paragraph (2) of this clause, and the contract price of the work not terminated.

c. Absent complete agreement under subparagraph b above, the Director shall pay the contractor the following amounts, provided payments agreed to under subparagraph b. shall not duplicate payments under this subparagraph for the following:

> (i) Contract prices for goods or services accepted under the contract;

(ii) Costs incurred in preparing to perform and performing the terminated portion of the work plus a fair and reasonable profit on such portion of the work, such profit shall not include anticipatory profit or consequential damages, less amounts paid or to be paid for accepted goods or services; provided that if it appears that the contractor would have sustained a loss if the entire contract would have been completed, no profit shall be allowed or included and the amount of compensation shall be reduced to reflect the anticipated rate of loss;

(iii) Costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to paragraph (1) of this clause. These costs must not include costs paid in accordance with subparagraph (ii) above.

(iv) The reasonable settlement costs of the contractor including accounting, legal, clerical, and other expenses reasonably necessary for the preparation of settlement claims and supporting data with respect to the terminated portion of the contract and for the termination of subcontracts thereunder, together with reasonable storage, transportation, and other costs incurred in connection with the protection or disposition of property allocable to the terminated portion of this contract. The total sum to be paid the contractor under this subparagraph shall not exceed the total contract price plus the reasonable settlement cost of the contractor reduced by the amount of

payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under subparagraph b. of this paragraph, and the contract price of work not terminated.

d. Cost claimed, agreed to, or established under subparagraphs b. and c. shall be in accordance with chapter 3-123, H.A.R. bearing on such claim.

<u>8.5 TERMINATION OF CONTRACTOR'S RESPONSIBILITY</u> - The contract will be considered complete when all work has been completed, the work accepted by the Director, and the final estimate paid. The Contractor will then be released from further obligation except as set forth in the contract and bond, when applicable.

<u>9.1 PAYMENT</u> - The Contractor's bid price shall be inclusive of all costs, direct or indirect, including all taxes, required for the fulfillment of this contract.

Contract payments to the Contractor by the State shall be full payment, for furnishing all labor, and for furnishing and delivering all equipment, materials, supplies and other incidentals to the location(s) designated in these specifications.

<u>9.2 PROGRESS PAYMENTS</u> - If more than one shipment is required under these specifications, progress payments may be made to the Contractor after each shipment, provided the equipment materials, supplies, etc., furnished and delivered have satisfactorily met the requirements of these specifications. Five per cent (5%) of the amount of each progress payment shall be retained by the Department until the final acceptance of the work.

To expedite processing of all payments, for item(s) furnished and delivered to the Department, the Contractor shall forward an original and one copy of invoice with each shipment made to the recipient office.

Each invoice shall contain the following:

A. Vendor's name, address and phone number.

B. Contract or Purchase Order No.

C. Description of item, the quantity, unit or lump sum price, sub-total and total.

<u>9.3 FINAL ACCEPTANCE AND FINAL PAYMENT</u> - Final acceptance means the acceptance in writing by the Director of the satisfactory completion of the work as provided under Section 8.5 followed by final payment in accordance with the Director's final estimate. The Department shall make final acceptance and payment promptly after the contract has been satisfactorily completed and final inspection made.

No payment will be made for any work which was not authorized by the Director in writing.

Final payment shall be made only after the issuance of the notice of final acceptance and after the Contractor has filed with the Director the following:

A. Consent of the Contractor's surety, when applicable, of the final payment;

B. Satisfactory evidence by affidavit that all debts resulting from the contract have been fully paid or satisfactorily secured;

C. A current "Certificate of Vendor Compliance" issued by the Hawaii Compliance Express (HCE). The Certificate of Vendor Compliance is used to certify the Contractor's compliance with (a) Section 103D-328, HRS (for all contracts \$25,000 or more) which requires a current tax clearance certificate issued by the Hawaii State Department of Taxation and the Internal Revenue Service; (b) Chapters 383, 386, 392, and 393, HRS; and (c) Subsection 103D-310(c), HRS. The State reserves the right to verify that compliance is current prior to the issuance of final payment. Contractors are advised that non-compliance status will result in final payment being withheld until compliance is attained.

The filing of willfully false affidavits will disqualify the Contractor from bidding on future work of the Department.

<u>SECTION 10 – FURNISHING AND DELIVERING TRAFFIC SIGNS</u>

10.1 DESCRIPTION OF WORK

This work shall consist of furnishing and delivering traffic signs on an "as-needed" basis during the Contract period for the islands of Oahu, Hawaii, Maui and Kauai; and delivered to the place designated herein, all in accordance with the requirements of these Specifications, the Standard Specifications and the Standard Plans.

10.2 GENERAL

- (A) Material.
 - 1. Materials shall conform to the Standard Specifications, the Standard Plans and these Specifications.

- a. Amendments to the Standard Specifications include the following changes to retroreflectorization:
 - 1. Retroreflectorization for Type III or IV retroreflective sheeting materials shall be in accordance with Section 750.01(C)(4), Type III or IV Retroreflective Sheeting (High Intensity) as amended by Section 750.01(E), Retroreflective Sheeting Materials dates 1/2/14.
 - 2. Retroreflectorization for Type XI retroreflective sheeting materials shall be in accordance with Section 750.01(A)(1), Retroreflectorization and 750.01(E), Retroreflective Sheeting Materials as amended on 1/2/14.
- b. Generals notes in the Standard Plans include specifications that sign details shall conform to the latest editions and their amendments of the following Federal Highway Administration plublications:
 - 1. MUTCD for Streets and Highways.
 - 2. Standard Alphabets for Highway Signs.
 - 3. Standard Highway Signs.

c. Refer to Section 10.6(C) Shop Drawings for additional requirements on nonstandard traffic signs.

10.3 MINIMUM QUANTITY OF STORED MATERIALS

- (A) Due to limited spaces in storage facilities in State baseyards, the Contractor shall store/stock a minimum quantity/inventory of ten (10%) percent of the estimated yearly quantity of each bid item in the Proposal Schedule in the Contractor's local storage facility. The stored items shall be readily available for furnishing and delivering to the State upon request and upon the issuance of a Purchase Order. The Contractor shall maintain the above-mentioned minimum quantity/inventory of stored/stocked materials by continued replenishment. Storing shall be incidental to the cost of furnishing and delivering the specified materials.
- (B) The State reserves the right to request the Contractor to furnish and deliver all estimated yearly quantity of each bid item in the Proposal Schedule upon the issuance of the Notice to Proceed or anytime during the term of the contract. When the State's order of materials exceeds the quantity of materials that is available in the Contractor's inventory in the local storage facility, the Contractor shall have a maximum of one hundred twenty (120) calendar days to deliver the remaining quantity.
- (C) To prolong the life of the specified materials, the Contractor shall protect the materials from the degradation effects of the weather and other elements or as prescribed by the manufacturer.

10.4 MINIMUM ORDER PER YEAR

The State shall place a **minimum** order of materials per year, at a minimum dollar amount of thirty (30%) percent of the respective District's total estimated maximum yearly contract cost in the Proposal Schedule

10.5 DELIVERY

(A) Description.

"DELIVERY" shall mean <u>transporting</u> of the specified materials to the respective addresses below and <u>unloading</u> and <u>stacking</u>, as applicable, to a location as directed by the recipient State. The Contractor shall <u>transport</u>, <u>unload</u> and <u>stack</u> the specified material utilizing his or her own equipment and personnel or his or her subcontractor's equipment and personnel. Cost of "delivery" as defined above shall be incidental to the cost of furnishing and delivering the specified materials.

(B) Coordination and Location of Deliver.

All deliveries under this contract shall be coordinated with the State or a duly authorized representative. Location of delivery and contact information is as follows:

(C) Packaging and Marking.

The material shall be packaged in convenient size, clean manufactured containers and marked for shipment in accordance with the respective address as specified in Section 10.5.B Coordination and Location of Delivery, in the quantities indicated in the Purchase Order or Proposal, as applicable. All cases shall be labeled to allow quick identification of the contents. Labeling shall contain the following information:

- 1. Material description
- 2. Size
- 3. Count
- 4. Trademark or trade name
- 5. Date of manufacture
- 6. Contractor's name

- 7. Contractor's address
- 8. Manufacturer's name
- 9. Manufacturer's address
- 10. Contract number
- 11. Project number

The bid price shall include the cost of containers, which shall become the property of the Department. The Contractor shall replace any highway pavement marker and/or adhesive material which have become unfit for use.

- (D) Delivery Period and Capability.
 - 1. Sustained Delivery Capability.
 - a. Upon the issuance of Purchase Order from the State, the Contractor shall have a <u>maximum of fourteen (14) calendar days</u> to furnish and deliver any materials that is in storage at the Contractor's local storage facility.

- b. When the State's order of materials exceeds the quantity of materials that is available in the Contractor's inventory in the local storage facility, the Contractor shall have a maximum of one hundred twenty (120) calendar days to deliver the remaining quantity.
- c. The Contractor shall maintain this sustained delivery capability through continued replenishment of inventory throughout the term of the contract.
- d. Refer to Section 8.2 Liquidated Damages for the amount that shall be assessed from the Contractor for failure to deliver in accordance with this Section.
- (E) Notification of Delivery.

The Contractor shall have the shipper notify the recipient district by calling or emailing the point of contact as listed in Section 10.5.B Coordination and Location of Delivery of this section at least five (5) working days in advance as to the day and time of delivery. The day and time of delivery shall be subject to approval of the State.

(F) Inspection of Material.

The Contractor and the State shall make a visual and physical check of the materials delivered for damage, shortages, etc. Payment will not be processed until the Contractor and State have both concluded that the materials delivered meet the contract requirements.

10.6 BIDDER/CONTRACTOR SUBMITTAL

If requested by the State contractors may be asked to provide documentation for each of the material described and in accordance with the schedule as specified in Section 10.6.D Schedule of Submitting Required Documents of this section, the Contractor shall submit the following documents electronically.

(A) Material Certificate of Compliance for traffic signs.

- 1. The Contractor shall certify that the materials delivered conform to the requirements of the Standard Specifications, the Standard Plans, and these Specifications.
 - a. The notarized certificate shall include, as a minimum, the following data:
 - i. Name of manufacturer
 - ii. Material being certified
 - iii. Batch or lot number or Purchase Order Number as applicable
 - iv. Applicable test results of finished products
 - v. Applicable specifications
 - vi. Date
 - vii. <u>Statement of compliance by a responsible official (employee) of the</u> <u>Manufacturer or by his representative. The Manufacturer's statement</u>

of compliance shall be endorsed by the Contractor. Both manufacturer's statement of compliance and the Contractor's endorsement shall be notarized. Project identification

(B) Warranty.

viii.

1. For retroreflective sheeting materials used in the manufacturing of traffic signs, the manufacturer warrants that the coefficient of retroreflection for the reflective sheeting for traffic signage components for traffic control and guidance signs shall meet the **minimum** coefficient of retroreflection in accordance with the Standard Specifications in the table below.

Such warranty or warranties shall be assigned to the State and submitted to the respective office as specified in Section 10.6 Bidder/Contractor Submittal.

(C) Shop drawings. Non-standard traffic signs in Appendices B through K shall be approved by the State.

(D) Schedule of Submitting Required Documents.

1. **Prior to award**: The Contractor shall electronically submit the <u>Material Certificate</u> of Compliance and Warranty to the Project Manager no later than <u>seven (7) working</u> <u>days</u> from the date of the written request by the State.

Failure by the bidder to submit: The bidder may be considered non-compliant with the requirements of the Specifications if the bidder fails to submit the specified documents later than <u>seven (7) working days</u> from the date requested by the State. This failure may result in bid rejection.

The Material Certificate of Compliance shall be reviewed by the Materials Testing & Research Branch and shall recommend acceptance or non-acceptance. The review process is estimated to be completed as early as five (5) working days and up to ten (10) working days from the time of receipt of the document(s). The Construction and Maintenance Branch shall send a letter or email to the Contractor stating those materials in the Certificate of Compliance are accepted or not accepted. If the material Certificate of Compliance is not accepted, it will be rejected and may result in bid rejection.

For each new order of materials, the Contractor shall require the manufacturer to furnish a material Certificate of Compliance. The Contractor shall furnish the certificate to the branch office as mentioned in Section 10.6 Bidder/Contractor Submittal and to the district offices (as applicable). Procedures for review and notifications shall be as specified in the paragraph above. Endorsement and notary shall be in accordance with Section 10.6(A)1.a.vii.

Pursuant to Section 106.01 Source of Supply and Quality Requirements, of the Standard Specifications, "All materials proposed to be used may be inspected and tested at any time and place including, but not limited to, the source of supply and locations of manufacture and fabrications.

If the State decides to test the specified materials, the Materials Testing and Research Branch will randomly select materials for testing from delivered materials from the district(s) and/or source of supply and locations of manufacture and fabrications. The Materials Testing and Research Branch will ship the samples to a third party testing facility and verify that the materials meet specifications.

- 2. **Prior to delivery**: The Contractor shall submit the Shop Drawings as specified in Section 10.6(C) of this section.
- 3. **Upon delivery:** The bidder shall submit the material Certificate of Compliance as specified in Section 10.6(A). <u>Delivered materials that are not compliant with the contract specifications shall be replaced by the Contractor at no cost to the State.</u>
- 4. When there are changes to the composition or manufacturing process of any material as specified in this contract: Throughout the life of the contract including any contract extension(s), report any changes, in writing, in the composition or manufacturing process of any material as specified in this contract to Construction and Maintenance Branch at the address as specified in this section. Any changes require a resubmission of Material Certificate of Compliance.

<u>10.7 TERM OF CONTRACT</u>: The term of this contract shall be for twelve (12) months from the date indicated on the Notice to Proceed from the State unless renewed as provided for in Section 10.8 Option to Extend Term, herein below.

10.8 OPTION TO EXTEND TERM: Subject to the availability of State funds, this contract may be extended up to four (4) additional twelve (12) month periods, or portions thereof, without the necessity for re-bidding upon mutual agreement between the State and the Contractor in writing provided the contract price for the extended period shall remain equal to or less than the initial bid price; with adjustments as provided in Section 10.9 Escalation Clause. The entire term of contract, including extensions, shall not exceed sixty (60) months.

10.9 ESCALATION CLAUSE:

During the contract extension process, the State shall automatically adjust the unit bid prices of the Proposal Schedule to match the index percentage change in accordance to the sample computations below. The change in price, higher or lower, will be amended by a written contract amendment.

When evaluating the material escalation, the Producer Price Index (Aluminum mill shapes, WPU 102501) of the U.S. Department of Labor, Bureau of Labor Statistics shall be used to calculate percent change. The calculated percent change shall apply to the unit bid price when calculating escalation for the applicable bid items.

If the price of material increases or decreases by fifteen percent (15%) no adjustment to the existing unit bid item prices will be made. Once the price of the applicable material goes past the 15% threshold, the responsibility will shift to the State. If the adjustment to the unit bid item price exceeds fifteen percent (15%), the State will provide an escalation for the additional percent above 15 or delta. If the adjustment to the unit bid item price is decreased by more than fifteen percent (15%), the State would lower the original unit bid item price by the additional percent or delta. For example, if the percent increase was calculated to be 20, the contractor would have a total escalation of 5% after subtracting 15% from the calculated 20%. Thus, the extension would increase the previous terms unit bid item price five percent for all applicable bid items. Another example would be if the percent decrease was calculated to be -20%, the State would lower the original unit bid items.

When computing calculations, the most recent data should be utilized even if it is preliminary data and compare it to the same month the previous year. Final calculated percentage should be rounded to the nearest whole number (.01 to .5 is rounded down and .51 to .99 is rounded up). Below are two sample computation examples on how the State will calculate percent change and apply it to the contract extension.
