- Excavation and removal of old existing water main section from main valve to greenhouse structure.
- Install approximately 120' of new Schedule 40 2" PVC irrigation pipe.
- Hauling in/out of new backfill material and spoils.
- Backfill/compaction.
- Grading to match existing grade.
- Install in-line valves (3-4) inside of greenhouse structure.
- Install/replace 3-4 connections along newly installed water main.
