TAX LIABILITY

Both out-of-state and Hawaii bidders are advised that the amount bid on this solicitation is subject to the general excise tax imposed by Chapter 237, Hawaii Revised Statutes (HRS) and, if tangible property is being imported into the State of Hawaii for resale, the use tax (currently 1/2%) imposed by Chapter 238, HRS. (Refer to Taxes in the General Provisions.) Bidders are therefore cautioned to consider such taxes in formulating their bids since no adjustments to the prices bid shall be allowed.

BASIS FOR AWARD

The award of contract, if awarded, shall be made to the lowest responsive and responsible bidder on the **TOTAL AGGREGATE BID (ITEM NOS. 1 & 2).**

NOTE TO BIDDERS

An acceptable bid must conform in all material respects to this Invitation for Bids. Any of the following may be grounds for disqualification:

- 1. Taking exception to any of the specifications, terms or conditions contained in the IFB.
- 2. Placing conditions on the furnishing of solicited goods or services.
- 3. Inclusion of a quotation or order form containing additional specifications, terms or conditions.

SPECIAL PROVISIONS

1. SCOPE

The Furnishing and Delivery of Vehicles for Fleet Service, University of Hawaii at Manoa, Honolulu, Hawaii shall be in accordance with the terms and conditions of IFB No. 24-094 and the General Provisions dated September 2013 included by reference. Copies of the General Provisions are available at the Office of Procurement and Real Property Management, University of Hawaii, 1400 Lower Campus Road, Room 15, Honolulu, Hawaii 96822 or the General Provisions may be viewed at: https://www.hawaii.edu/procurement/vendor-info/terms-and-conditions/general-provisions-for-goods-and-services/

2. AUTHORITY

IFB No. 24-094 is issued under the provisions of the Hawaii Revised Statutes, Chapters 103 and 103D. All prospective bidders are charged with presumptive knowledge of all requirements of the cited legal authorities. Submission of a valid executed bid by any prospective bidder shall constitute an affirmation of such knowledge on the part of such prospective bidder.

3. TECHNICAL REPRESENTATIVE OF THE PROCUREMENT OFFICER (TRPO)

4. SUBMITTAL OF TECHNICAL DATA

With their bids, bidders shall submit, in duplicate, manufacturer's literature or brochures with technical data and illustrations of the vehicle being offered.

5. DELIVERY

Delivery of all vehicles shall be made within ONE-HUNDRED TWENTY (120) consecutive calendar days from the date designated in the Notice to Proceed. The Contractor shall contact the Technical Representative to coordinate delivery for the vehicles being furnished under this contract. All vehicles shall be delivered to University of Hawaii at Manoa Fleet Services, 2027 East-West Road, Honolulu, Hawaii 96822.

6. MANUALS AND INSTRUCTIONS

The Contractor shall provide the University with operating and maintenance manuals of the vehicles furnished under this contract except when hardcopy manuals or CD versions are no longer produced by the vehicle manufacturer for distribution.

7. WARRANTY

The vehicles furnished shall be new and as specified. The Contractor shall warrant that all workmanship and materials of vehicles furnished under this contract shall be guaranteed for a period of SEVEN (7) years/75,000 miles from the date of acceptance. The Contractor shall replace and/or repair any defective workmanship and/or materials at no cost to the University during the period of warranty, provided such defects are not due to abuse or negligence on the part of the University.

8. MAINTENANCE

Maintenance and spare parts shall be available locally. All maintenance services must be prompt and effective and shall be performed by qualified mechanics.

9. PAYMENT

The Contractor shall be remunerated upon satisfactory delivery and acceptance of the vehicle, and submission of a properly executed original invoice and ONE (1) copy, indicating the contract number, to Auxiliary Services Fiscal Office, 1951 East-West Road, Honolulu, Hawaii 96822.

10. CERTIFICATES REQUIRED

Prior to delivery, the Contractor shall obtain the following and deliver to the University together with the vehicles:

- a. Hawaii Safety Inspection Certificate (in duplicate) and decal;
- b. Motor Vehicle Registration Certificate (completed and signed); and
- c. Odometer Certificate.

11. STATE LICENSE FOR SELLING MOTOR VEHICLES

Chapter 437, Hawaii Revised Statutes, provides for regulating and licensing of motor vehicle manufacturers and distributors, and their branches and representatives, motor vehicle dealers, salesmen, auctions and auctioneers and any other persons engaged in the business of selling or purchasing motor vehicles in the State of Hawaii; therefore, all prospective bidders who are interested in selling motor vehicles to the University of Hawaii shall provide proof that they do meet and satisfy the licensing requirement set forth in said statute by listing the license number in the space provided on the Mandatory Bid Form.

"Motor vehicle" includes any vehicle, motor vehicle, or truck, as defined in Sections 249-1 and 240-2, HRS, except for tractors, trailer, and amphibious vehicles.
