The Department of Land and Natural Resources, Division of Aquatic Resources (DLNR-DAR) is requesting bids for one (1) new 2024 26ft heavy-duty aluminum tandem axle boat trailer with a load capacity of 8,500 lbs. delivered by October 31, 2024, to Oahu, as specified herein. We are looking to replace a trailer for our 26ft Boston Whaler. This new trailer must be an aluminum I-beam construction with a tandem axle. The trailer shall be new and of current manufacture. If the trailer is to be delivered from the mainland, shipping to the Port of Honolulu, HI must be included in the total bid cost. The delivered trailer must be able to be picked up by the Oahu DAR team with a truck at any location on the island of Oahu.

Successful applicant shall be notified by email and work may not begin until issuance of Purchase Order (PO) Agreement and Notice to Proceed (NTP). At the time of the Award, applicant shall be compliant with the State's Rules and Regulations through the Hawaii Compliance Express. If not compliant, award shall not be issued.
