The Department of Health, State Laboratories Division (SLD) is requesting a price quote to decontaminate rooms using Vaporized Hydrogen Peroxide (VHP) at 2725 Waimano Home Road, Pearl City, Hawaii 96782.

A. SCOPE

Bidder will provide all equipment, materials, and labor necessary to perform the following:

- Bidder shall appropriately seal room and decontaminate BSL-3 Laboratory space in room numbers 2210, 2211, 2212 2205, 2204, 2203, 2206 using VHP. This space has a combined floor area of approximately1600 ft² and 9foot-high ceilings. See attach drawing for room dimensions.
- 2. Bidder shall appropriately seal room and decontaminate BSL-2 Laboratory space in rooms 2101, 2104, 2106, 2105 using VHP. This space has a combined floor area of approximately 650 ft² and a ceiling height of about 9 feet. See attach drawing for dimensions.
- 3. Bidder shall appropriately seal room and decontaminate BSL-2 Laboratory space in rooms 2510, 2502, 2503, 2509 using VHP. This space has a combined floor area of approximately 750 ft² and a ceiling height of about 9 feet. See attach drawing for dimensions.
- 4. Bidder shall provide verification of successful bio-decontamination. Bidder shall ensure that an adequate number of biological indicators are placed to verify successful decontamination. Initial report shall be available approximately 24 hours after bio-decontamination with a final report available within one week of decontamination.
- 5. Repeat decontamination if verification fails at no additional cost to the State.
- 6. Bidder shall be responsible for all expenses and requirements related to travel, accommodation, food, etc.

- 7. The State is currently anticipating that this work will need to be scheduled on Saturday August 3, 2024 and/or Sunday August 4, 2024, however these dates may change to a different weekend. Dates will be finalized no later than 3 weeks prior to the work date.
- 8. Decontamination should not damage or leave residues on equipment or supplies left in the room.
- 9. Please upload information regarding the VHP system/equipment to be used and any pre-decontamination requirements with Bid on HIePRO.
- 10. All work must be done in compliance with all Federal and State Laws. This includes but is not limited to Hawaii Revised Statutes §103-55.
- B. Other Requirements:

Bidder must be compliment on Hawaii Compliance Express or provide documentation of compliance to be eligible for award.

Bidder must provide 3 references for similar decontamination work performed within the United States (see attached form).

Please see HIePRO instructions for other additional requirements.

C. Bid price:

Bid prices shall include labor, equipment, supplies, transportation, incidentals, all applicable taxes and any other costs incurred to furnish the decontamination services as requested. Bids will be evaluated based on lowest responsible, responsive offer.





The Procurement Officer may reject any or all quotes and waive any defects if the Procurement Officer believes the rejection or waiver is in the best interest of the State.
