## **DETAILED SPECIFICATIONS**

The following accommodations and/or amenities will need to be provided. No substitutions will be allowed.

- Lodging facility shall be within a 15-mile radius to the Aloha Stadium located at 99-500 Salt Lake Boulevard, Aiea, Oʻahu, Hawaiʻi.
- Lodging facility shall be within a 12-mile radius to the Daniel K. Inouye International Airport.
- Lodging facility shall be within a 5-minute walk to restaurants and food court facilities.
- Lodging facility shall be within a 5-minute walk to shops that offers for sale basic hygienic supplies and comfort living supplies.
- At a minimum, rooms shall be outfitted with 2 double beds, a night stand with two drawers, and two bed lamps.
- Lodging facility shall provide complimentary housekeeping/maid services.
- At a minimum, rooms shall be equipped with a bathroom consisting of a clean flushable toilet with complimentary toilet paper, stand-in shower/tub combination with complimentary shower hygienic products, blow drier, complimentary towels for two guests and an operable sink, vanity and mirror. Complimentary shower and hygienic products to be replaced upon request.
- Rooms shall be equipped with a dresser and enclosed closet system capable of storing clothes for two occupants, as well as complimentary iron and ironing board.

- Lodging facility shall have a 24-hour on-site certified security personnel and services.
- Lodging facility shall have a complimentary air-conditioned fitness center equipped with various and operable fitness gear and apparatuses.
- Lodging facility shall have an operable and air-conditioned elevator system.
- Lodging facility shall have a fire escape plan that's visible, legible, and accessible on the room doors and in the corridors.
- Lodging facility shall have a 24-hour business center and dry cleaning/laundry services.
- Lodging facility shall have a fitness center and pool facility.
- Lodging facility shall have available an operable on-site ice maker.
- Lodging facility shall have available an operable and stocked snack and drink vending machine.
- Self-parking and valet parking available onsite with sufficient stalls to accommodate 4 vehicles and/or parking stalls to accommodate a 15-passenger sized van(s).
- Be able to effect an infectious disease facility safety plan pursuant to the Centers for Disease Control and Prevention (CDC), State of Hawai'i Department of Health (DOH) guidelines and the Office of the Governor's emergency proclamation should there be a declaration involving an infectious disease or diseases.
- Lodging facility and rooms shall have a disinfecting and cleaning schedule or shall have it available upon request.
- Lodging facility shall have an employee and guest infectious diseases exposure plan should a declaration be announced and affirmed.

- Property follows regional sanitization guidelines pertaining to infectious diseases Health & Safety Standards (Hawai'i - USA).
- Property follows a brand or regulatory agency's sanitization guidelines ALLSAFE (Accor Hotels).
- Lodging facility shall have an available contactless check-out system.
- Lodging facility shall be American with Disabilities Act (ADA) compliant and accessible.
