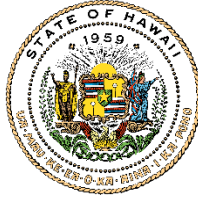

Bidding Information:

- Bid Deadline: July 17, 2024 at 2:00 PM.
- All interested bidders must be registered in **HlePRO** prior to bid deadline.
- Bidders shall download, fill out, and upload bids on the Proposal Form attached to the bid solicitation and all required attachments:
 - Apprenticeship Program Participation Form 1 (optional)
 - Bid Bond (required)
- RFIs may be submitted through the HlePRO question/answer section of the solicitation or sent directly to: finn.d.mccall@hawaii.gov. All pertinent RFI responses will be responded to via addendum.
- Deadline for submission of RFIs/questions: July 8, 2024 by 4:00 PM.
- Responses to RFIs/questions: No later than July 12, 2024 by 4:00 PM.
- Contract award contingent on contractor compliance with Hawaii Compliance Express (HCE) and availability of funds. See Notice to Bidders for more information.

Scope of Work:

- Survey stakeout for limits of excavation/dredging/stockpile site (licensed surveyor)
- Construction of stockpile site including grading for access road, construction ingress/egress, and BMPs
- Excavation of accumulated volcanic debris behind shoreline

- Dredging of entrance channel to boat ramp

Construction Items/Additional Work/Time Extensions:

- Permits: USACE, Grading, and Stockpiling permits to be obtained (applications already submitted by DOBOR), NTP may be delayed pending receipt of permits. DOBOR exempt from SMA and building permits.
- See Specification Section 01570 Environmental Control for contractor's pre-construction survey requirements for permits
- Staging/stockpiling areas: As shown on plans/coordinate with Engineer.
- Awarded contractor shall provide submittals/shop drawings as soon as possible after contract award
- Contract duration noted in bid proposal shall include time required to mobilize all required equipment, construction stockpile site, and setup BMPs
- Contract duration: 180 calendar days
- Estimated construction start: September 3, 2024
- Estimated completion date: May 30, 2025
