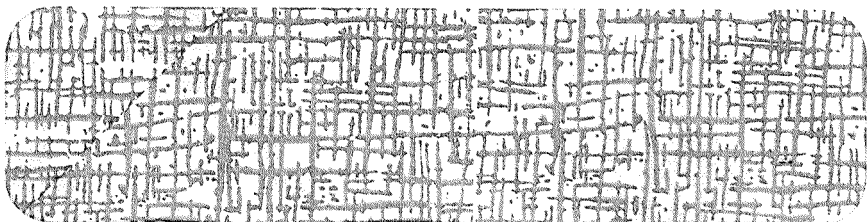


CIRCUIT COURT OF THE FIFTH CIRCUIT
