Notice is hereby given that pursuant to Chapter 102D, Hawaii Revised Statutes (HRS), The State of Hawaii, Department of Corrections and Rehabilitation, Food Service Branch will be accepting bids to provide One (1) Vulcan Model VC55GD Double Deck Gas Convection Oven for the Hawaii Community Correctional Center (HCCC) Food Service) – Hale Nani Facility.

**I. EQUIPMENT**

Vulcan Moedel VC55GD Double Deck Gas Convection Oven with Removable Doors. Optional equipment such as corrections package, casters, etc. are not needed. Please refer to Attachment B in the Line Items Tab for specifications.
