1. **QUESTION:** Can you explain the difference between Proposal Schedule 01562.1 and 01562.2. The specification section 01562.2 shows 01562.2 Products (Not Used).

**RESPONSE:** 01562.1 includes the management of known contaminated media identified in the hazmat survey, whereas 01562.2 includes the management of unknown contaminated media that has not been identified but may be discovered during construction.

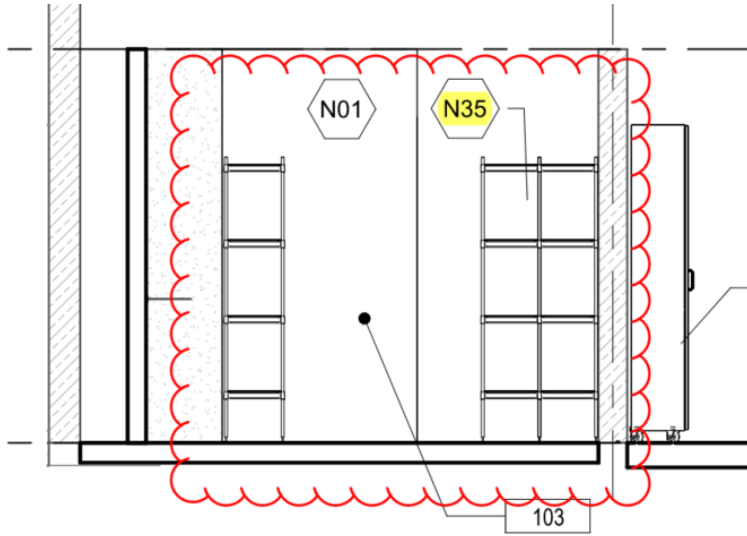
2. **QUESTION:** Sheet PD101 has callout to “Remove (E) gas range, modify (E) gas line for new range connection. If there is a new oven-range to be provided, please provide specifications.

**RESPONSE:** Commercial Grade 60” Gas Range – 6 open burners/ 24” griddle. Refer to equipment schedule.

3. **QUESTION:** Reference Equipment Schedule Sheet A-603, Item E01 – Range
  - a. Please specify make and model number for this item.
  - b. Will a gas hose be required, or will this be covered by Plumbing?

**RESPONSE:** A flexible stainless steel gas line is required for new gas range, and it’s covered in plumbing spec section 15410.

4. **QUESTION:** Reference Equipment Schedule Sheet A-603, Item E04 – Sliding Storage Shelves
  - a. Please confirm if these units are to be “Sliding” storage shelves. Sheet A-302, Elevation 1, N35 shows this to be stationary shelving units. Also shown on A-603 floor plan as stationary.
  - b. Please specify make and model number for this item.

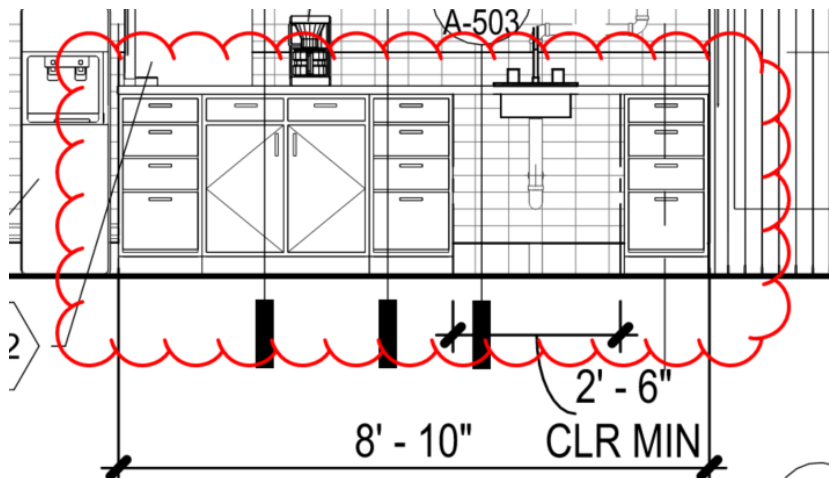


**RESPONSE:** Confirmed. Unit to be a “sliding” storage shelve system.

Please specify make and model number for this item.

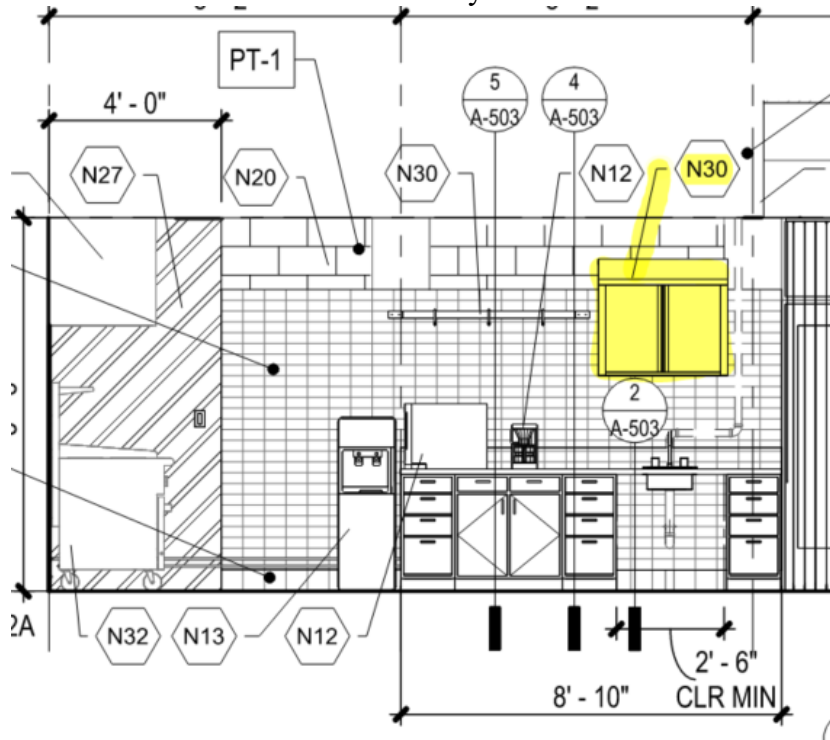
**RESPONSE:** Commercial Grade 32” x 23.5” x 22.38” ADA compliant undercounter dishwasher.

Are there more fabrication details for these items?



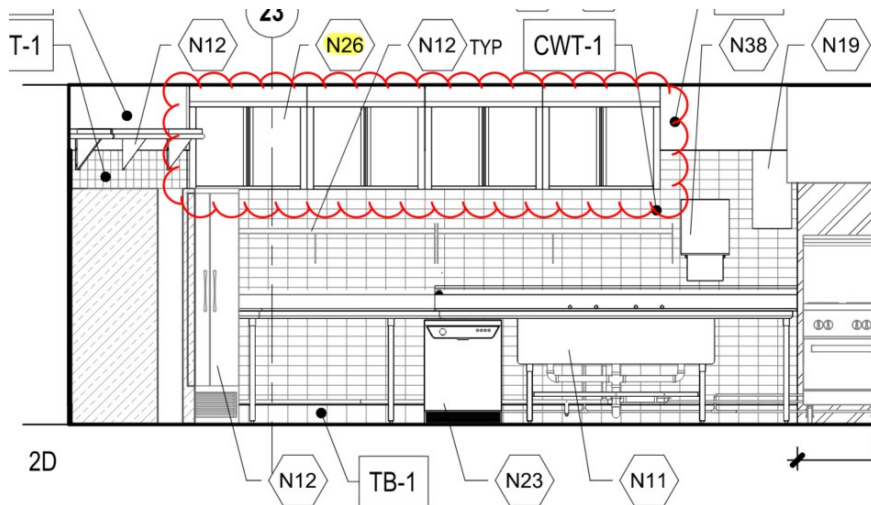
**RESPONSE:** Commercial Grade pmanufactured freestanding SST base cabinets. Refer to casework details.

b. If this is to be included in pricing, are there more fabrication details for this item?

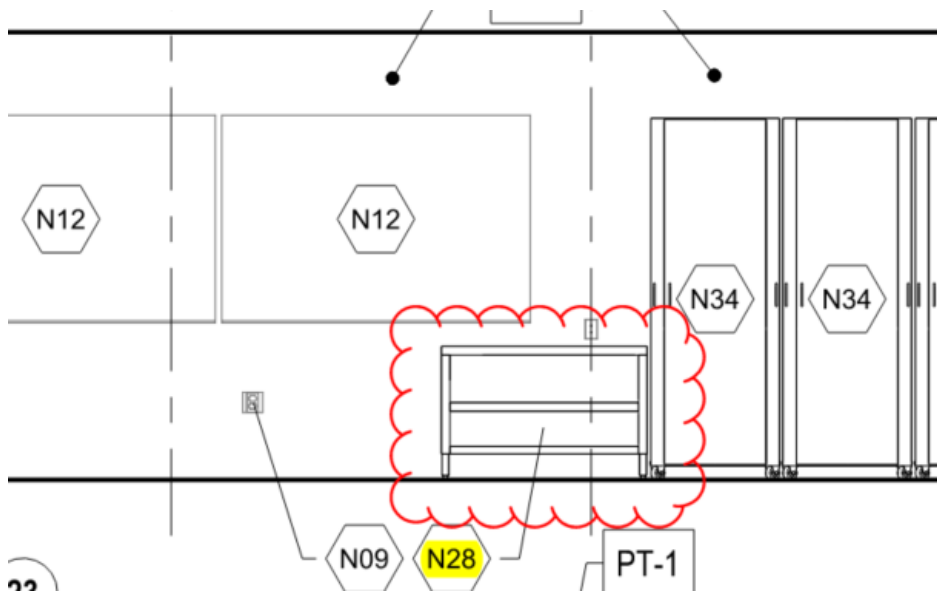
