

2024–2025 LABORATORY GAS SPECIFICATIONS

CONTRACT PERIOD: December 1, 2024 to November 30, 2025

COMMITMENT: The Hawaii State Department of Health (DOH) State Laboratories Division (SLD) Biological Response Section (BRS) and Chemical Response Section (CRS) will purchase from the successful bidder's submitted price list except as indicated below in **EXCEPTION TO THIS PRICE LIST**. Orders shall be issued on an as-needed basis during the period covered by this award. Vendor shall not be obligated to accept any order received after the award's expiration date. However, Vendor shall fill orders for which delivery may extend beyond the expiration date. Orders will not be issued specifying delivery after the award's expiration date.

EXCEPTION TO THIS PRICE LIST: In the event that the Vendor is unable to fulfill its contractual obligations, required supplies may be purchased from other vendors.

LABORATORY GAS COST TABLE (SUBMIT WITH BID): Vendor must complete the attached Laboratory Gas Cost Table. When presented with a range (i.e. 200-300 cu ft), Vendor may input pricing for smallest size available. Please specify size.

CYLINDER CAPS: Vendor shall provide standard cylinder caps for compressed gases. Variations such as SMARTOP caps are not allowed.

CERTIFICATE OF ANALYSIS: Vendor must provide a Certificate of Analysis (COA) upon request at no charge.

CERTIFICATE OF CONFORMANCE: Vendor must provide a Certificate of Conformance (COC) upon request at no charge and may be asked to provide them during the bidding process.

DELIVERY: Vendor shall deliver all items in satisfactory condition to the designated room or area as directed. There shall be no pick-up and/or delivery on Saturday, Sunday or State holiday. The following delivery provisions shall apply:

Regular Delivery of Vendor-owned Cylinders: All gases shall be delivered within six (6) working days after receipt of purchase order or pCard order.

Regular Delivery of Customer-owned Cylinders: Empty cylinders shall be picked up by the Vendor within six (6) working days after receipt of purchase order or pCard order; filled cylinder shall be returned within six (6) working days after pick-up.

Next Day Rush Delivery: Rush Delivery shall apply to Vendor-owned cylinders only. Requests for rush deliveries shall be received by 12:00 noon, whereby the Vendor shall deliver the order on or before 4:00 pm the following day, at the Rush Delivery Charge of not more than \$250.00.

CYLINDER ID NUMBER: The Vendor must include Cylinder ID Numbers on delivery slips, pick-up slips, and rental invoices to enable tracking of cylinders.

HYDROSTATIC TESTING: Hydrostatic testing for customer-owned cylinders must be provided by the Vendor. All Vendor supplied cylinders must be current on hydrostatic testing for the duration of the contract period.

LOST, MISPLACED, LEAKING OR DAMAGED BEYOND REPAIR OF VENDOR-OWNED CYLINDERS/VGLS BY CUSTOMER: For each lost or damaged beyond repair cylinder, the customer shall be charged not more than \$450.00 per 200-300 cu ft cylinder, and not more than the \$4000.00 per 100+ liter VGL. If a cylinder is leaking, or in any other way defective, the Vendor shall deliver a filled replacement cylinder within twenty-four (24) hours after notification by the customer.

LOST, MISPLACED, OR DAMAGED BEYOND REPAIR OF CUSTOMER-OWNED CYLINDERS/VGLS BY VENDOR: The customer shall be notified immediately. Cylinder shall be replaced at Vendor's expense within three (3) working days.

VALVE REPAIRS AND/OR REPLACEMENTS: All repairs and/or replacements on customer-owned cylinders and VGLs must be done only after proper approval from the customer has been obtained by the Vendor. Such repair and/or replacement of valves must be listed separately on the invoices.

AWARDING WINNING BID: The contract shall be awarded to the lowest responsible bidder as determined by the Laboratory Gas Cost Table. Any bid that does not include the requested **(SUBMIT WITH BID)** items on this solicitation may be disqualified. Only the awarded Vendor shall refill leased cylinders.
