SCOPE OF WORK

The Air Surveillance & Analysis Section (ASAS) is requesting quotes to move an air monitoring shelter located at Ko Olina Resort, Oahu to Mountain View, Hawaii. Interested contractors may bid on moving services only for the island of Oahu, as described below:

1. Picking up an 8'W x 16'L x 8'H shelter weighing approximately 3000 lbs. and shipping it to Hilo. The shelter is used to house air monitoring equipment. The shelter is located at Ko Olina Resort (Google

There is a security fence surrounding the shelter. Contractor shall remove security fence (including gates, posts, etc.), restore (backfill dirt in holes left by fence posts) and dispose of all fence materials. Loading the shelter on to a flatbed will probably involve using a forklift or possibly a crane.

- 2. Transporting the shelter from Ko Olina location to a shipping company for shipment to Hilo.
- 3. Making arrangements to ship the shelter to Hilo (including completing shipping forms as needed. May require a shipping platform.

INSURANCE AND LICENSES: The Contractor shall maintain General Liability Insurance from an insurance company to cover bodily injury and/or property damage directly due to the negligence of the Contractor, his/her agents or his/her employees. The Contractor shall maintain Workmen's Compensation Insurance in accordance with State requirements. The Contractor shall maintain the following:

- Business License
- Registered with the Hawaii Compliance Express
- Commercial Auto Insurance Policy

Bid proposals shall be electronically submitted via HIePRO no later than 2:00 p.m. on <u>Friday, May 13, 2016</u>. The Contractor shall include all taxes and all applicable fees in its bid proposal. Only responses submitted through HIePRO shall be considered for award.
