3. Odometer Certificate;
4. Notarized Certificate of Bill of Sale;
5. Certificate of Weight and Measures (required if factory-furnished vehicle weight is unavailable), which shall include make, model number, year, and vehicle identification number. Verified weight in pounds must be officially machine-stamped (handwritten weight shall not be accepted);
6. Certificate of origin;
7. Temporary license plates to be used during the interim period prior to acquisition of State of Hawaii license plates.

Acceptance of payment for the vehicles delivered will not be made without inclusion of the required documents and certificates. The STATE shall be responsible for registration and obtaining licenses for this vehicle.
