

GENERAL SPECIFICATIONS FOR DLNR-DOCARE UNIFORMS

The Department of Land and Natural Resources-Division of Conservation and Resources Enforcement (DOCARE) provides its officers with the uniforms, jackets and headgear as specified herein. As these officers are in the public eye, it is essential that the vendor awarded this contract ensures color consistency among the shirts, pants and other items.

Interested parties are advised that the uniforms will require an initial sizing and must be fitted to individual officers. ***Bidders shall have a business in the State of Hawaii on the Island of Oahu or provide the name and contact information of its subcontractor to provide initial sizing and alteration services.*** As DOCARE is a statewide agency, the vendor awarded this contract must be willing to travel throughout the State of Hawaii to conduct the sizing and fitting of uniforms as necessary.

Bidder must be able to provide the uniforms as specified, and provide the necessary alterations, sewing, and embroidery.

INVOICING AND PAYMENT

The Department shall be responsible for the entire cost of the initial issue uniforms, and jackets as ordered.

Pricing shall include the shipping, tax, sizing, alterations, collar tabs, embroidery and sewing of name tape, service stars, and sewing of Patches. Badge and Shoulder patches will be provided.

QUANTITY OF UNIFORMS

DOCARE has seven (7) new employees who are required to wear and be issued uniforms. The following quantity of uniforms are required per employee:

Short Sleeve Uniform Shirt	1
Long Sleeve Uniform Shirt	1
Polo Style Shirt	5
Pants	5
Jacket	1
Black Tie	1

For information relating to the Uniform style, material and color, refer to the Detailed Specifications.

The vendor must be able to provide a fit line of all garments requested in order to assist in determining the appropriate size of the garments for each employee.

UNIFORM SIZING REQUIREMENT

For all garments requested, the awarded vendor must be able to provide all sizes, ranging from extra-small to 5-extra large (XS-5XL), for both males and females.

DELIVERY

Uniforms will need to be delivered to the appropriate DOCARE Branch Office for which the Officer is assigned.

DETAILED SPECIFICATIONS FOR DOCARE UNIFORMS

All garment details not specifically described herein; tailoring, styling, construction, materials, and components must match the model being requested. Silence of the specifications does not absolve bidders from matching with precision, the requested model.

SHORT SLEEVE SHIRTS (FOR MALE PERSONNEL):

Blauer SUPER SHIRT, Model 8675 SS, or equal. 8 oz. washable 100% fade resistant polyester with 10% stretch and wicking finish. Abrasion resistant, stretch nylon mesh side panels provide advanced breathability and a custom tapered fit. Special function pleated patch pockets with hook-and-loop flaps, pencil slots, and secure vertical compartment behind the pocket for glasses or documents. Adaptive visibility provided by deployable reflective trim on pocket panels, inside cuffs and underside of rear collar provide 360 degree nighttime visibility. Port opening on sides for microphone ear piece connection to radio. Zippered front with mock buttons. Center-positioned microphone/camera tab for ease of use. Extra-long shirt tails. Convertible sport collar. Traditional 5-crease military style (stitched). 2-button adjustable cuffs. Reinforced epaulets. Badge with internal support strap. Shirt will be Silver-Tan in color.

DOCARE will provide patches and emblems for sewing onto uniforms. Vendor will use matching thread to conceal stitching and provide embroidered nametags ¼" tall (1 each black thread) for each short sleeve shirt on matching material of shirt. Nametags will be centered on the right breast pocket of flap. Vendor will also sew appropriate number of service stars, with black thread on the seam of the right pocket flap, above the name tape. The Department patch will be sewn on the left sleeve with the top of the patch ½" below the shoulder seam. The Colored State of Hawaii Flag patch will be sewn on the right sleeve with the top of the patch ½" below the shoulder seam.

SHORT SLEEVE SHIRT (FOR FEMALE PERSONNEL):

Blauer SUPER SHIRT, Model 8675W SS, or equal. 8 oz. washable 100% polyester with 10% stretch and liquid repellent finish. Abrasion resistant, stretch nylon mesh side panels provide advanced breathability and a custom tapered fit. Special function pleated patch pockets with hook-and-loop flaps, pencil slot left, and secure vertical compartment for glasses or documents. Adaptive visibility provided by deployable reflective trim on pocket panels, inside cuffs and underside of rear collar provide 360 degree nighttime visibility. Zippered front with mock buttons. Center-positioned mic tab for ease of use. Extra-long shirt tails. Convertible sport collar. Traditional 5-crease military style (stitched). 2-button adjustable cuffs. Reinforced epaulets. Badge with internal support strap. Shirt will be Silver-Tan in color.

DOCARE will provide patches and emblems for sewing onto uniforms. Vendor will use matching thread to conceal stitching and provide embroidered nametags ¼" tall (1 each black thread) for each short sleeve shirt on matching material of shirt. Nametags will be centered on the right breast pocket of flap. Vendor will also sew appropriate number of service stars, with black thread on the seam of the right pocket flap, above the name tape. The Department patch will be sewn on the left sleeve with the top of the patch ½" below the shoulder seam. The Colored State of Hawaii Flag patch will be sewn on the right sleeve with the top of the patch ½" below the shoulder seam.

LONG SLEEVE SHIRTS (FOR MALE PERSONNEL):

Blauer SUPER SHIRT, Model 8670 LS, or equal. 8 oz. washable 100% polyester with 10% stretch and liquid repellent finish. Abrasion resistant, stretch nylon mesh side panels provide advanced breathability and a custom tapered fit. Special function pleated patch pockets with hook-and-loop flaps, pencil slot left, and secure vertical compartment for glasses or documents. Adaptive visibility provided by deployable reflective trim on pocket panels, inside cuffs and underside of rear collar provide 360 degree nighttime visibility. Zippered front with mock buttons. Center-positioned mic tab for ease of use. Extra-long shirt tails. Banded dress collar. Traditional 5-crease military style (stitched). 2-button adjustable cuffs. Reinforced epaulets. Badge with internal support strap. Shirt will be silver-tan in color.

DOCARE will provide patches and emblems for sewing onto uniforms. Vendor will use matching thread to conceal stitching and provide embroidered nametags ¼" tall (1 each black thread) for each short sleeve shirt on matching material of shirt. Nametags will be centered on the right breast pocket of flap. Vendor will also sew appropriate number of service stars, with black thread on the seam of the right pocket, above the name tape. The Department patch will be sewn on the left sleeve with the top of the patch ½" below the shoulder seam. The Colored State of Hawaii Flag patch will be sewn on the right sleeve with the top of the patch ½" below the shoulder seam.

LONG SLEEVE SHIRT (FOR FEMALE PERSONNEL):

Blauer SUPER SHIRT, Model 8670W LS, or equal. 8 oz. washable 100% polyester with 10% stretch and liquid repellent finish. Abrasion resistant, stretch nylon mesh side panels provide advanced breathability and a custom tapered fit. Special function pleated patch pockets with hook-and-loop flaps, pencil slot left, and secure vertical compartment for glasses or documents. Adaptive visibility provided by deployable reflective trim on pocket panels, inside cuffs and underside of rear collar provide 360 degree nighttime visibility. Zippered front with mock buttons. Center-positioned mic tab for ease of use. Extra-long shirt tails. Banded dress collar. Traditional 5-crease military style (stitched). 2-button adjustable cuffs. Reinforced epaulets. Badge tab with internal support strap. Shirt will be silver-tan in color.

DOCARE will provide patches and emblems for sewing onto uniforms. Vendor will use matching thread to conceal stitching and provide embroidered nametags ¼" tall (1 each black thread) for each short sleeve shirt on matching material of shirt. Nametags will be centered on the right breast pocket of flap. Shoulder patch will be placed on left sleeve. Vendor will also sew appropriate number of service stars, with black thread on the top seam of the right pocket, above the name tape. The Department patch will be sewn on the left sleeve with the top of the patch ½" below the shoulder seam. The Colored State of Hawaii Flag patch will be sewn on the right sleeve with the top of the patch ½" below the shoulder seam.

POLO SHIRT (FOR MALE PERSONNEL):

Blauer Performance Pro Polo, Model 8139, or equal. Lightweight, moisture wicking polyester and mesh to ensure breathability and quick dry comfort. Anti-microbial technology, loose athletic cut and raglan design for full range of motion. Pick and pill resistant polyester knit.

DOCARE will provide a badge patch to be sewn onto the left chest area of the shirt. Vendor will embroider the Officer's name directly onto the right chest area of the shirt with black thread, Letter size will be ½". The Officer's title (i.e. Lieutenant, Officer, etc) will be embroidered under the Officer's name in black thread, letter size will be ½". The Department patch in subdued color will be sewn on the left sleeve with the top of the patch ½" below the shoulder seam. The State of Hawaii Flag patch in subdued color will be sewn with the top of the patch ½" below the shoulder seam.

Vendor will silkscreen the design in Attachment #1 on the back of the Polo Shirt. The design shall be centered on the back of the Polo Shirt, 4 inches down from the edge of the collar. The color of the design shall be black and in block capital lettering. Vendor will provide a photo sample of the silkscreen design for the Polo Shirt for approval before printing.

POLO SHIRT (FOR FEMALE PERSONNEL):

Blauer Performance Pro Polo, Model 8139W, or equal. Lightweight, moisture wicking polyester and mesh to ensure breathability and quick dry comfort. Anti-microbial technology, loose athletic cut and raglan design for full range of motion. Pick and pill resistant polyester knit.

DOCARE will provide a badge patch to be sewn onto the left chest area of the shirt. Vendor will embroider the Officer's name directly onto the right chest area of the shirt with black thread, Letter size will be ½". The Officer's title (i.e. Lieutenant, Officer, etc) will be embroidered under the Officer's name in black thread, letter size will be ½". The Department patch in subdued color will be sewn on the left sleeve with the top of the patch ½" below the shoulder seam. The State of Hawaii Flag patch in subdued color will be sewn with the top of the patch ½" below the shoulder seam.

Vendor will silkscreen the design in Attachment #1 on the back of the Polo Shirt. The design shall be centered on the back of the Polo Shirt, 4 inches down from the edge of the collar. The color of the design shall be black and in block capital lettering. Vendor will provide a photo sample of the silkscreen design for the Polo Shirt for approval before printing.

PANTS (FOR MALE PERSONNEL):

Blauer BDU Tactical Pant, Model 8830 or equal. Durable ripstop cotton blend fabric weave. Straight leg athletic cut for freedom of movement and uniform appearance. Comfort stretch waist band with even sizing. 10 Pocket design for equipment storage. Pants will be OD Green in color.

PANTS (FOR FEMALE PERSONNEL):

Blauer BDU Tactical Pant, Model 8830W or equal. Durable rip-stop cotton blend fabric weave. Straight leg athletic cut for freedom of movement and uniform appearance. Comfort stretch waist band with even sizing. 10 Pocket design for equipment storage. Pants will be OD Green in color.

NECK TIE, BREAK-AWAY STYLE, BLACK:

Galls Break-Away Tie, Model UA 495, or equal, Black Color, 18 inch length, Break-Away style of tie that slips off easily when pulled. 100% polyester. Pre-tied. Hook and loop fasteners. 3" wide with permanent knots.

EMBROIDERY AND PATCH SEWING:

On all shirt types, embroidery will be black thread. For polo shirts, the letter size will be ½" in capital letters. For long and short sleeve shirts, letter size will be ¼" in capital letters.

Garments that require shoulder patch sewing will have the Department patch sewn on the left sleeve, with the top of the patch ½" below the shoulder seam.

Garments that require the State of Hawaii Flag patch will be sewn on the right sleeve, with the top of the patch ½" below the shoulder seam.

Garments that require badge patch sewing will have the badge patch sewn on the upper left torso of the garment.
