NOTICE TO ALL PROSPECTIVE OFFERORS

This Addendum is hereby made a part for the Request for Proposals (RFP). The following questions were received from prospective Offerors. The Hawaii State Public Library System (HSPLS) responses are as follows:

QUESTION #1

On the Offer Form (OF-2), Shipping and Handling is listed as an item for which vendors are to provide a percentage discount. Is the Library looking for a specific discount off of shipping charges or should this reflect shipping charges as a percentage of the invoice total?

RESPONSE #1

The discount percentage for shipping and handling is a discount off the actual costs of shipping and handling.

QUESTION #2

Section 2 (d) of the General Conditions states that "The CONTRACTOR shall be responsible for payment of all applicable federal, state, and county taxes and fees which may become due and owing by the CONTRACTOR by reason of this Contract, including but not limited to (i) income taxes, (ii) employment related fees, assessments, and taxes, and (iii) general excise taxes." In Section 3.4 of the RFP document, it states that HSPLS will pay taxes as a separate line on invoices. Can you confirm that the State will be paying all excise taxes?

RESPONSE #2

All applicable taxes shall be invoiced as a separate line item.

QUESTION #3

Regarding Section 7 (Indemnification and Defense) of the General Conditions, can you confirm that this clause relates to claims made by a third party against the State of Hawaii, the contracting agency, and their officers, employees and agents?

QUESTION #4

Regarding Section 8 (Cost of Litigation) of the General Conditions, can you confirm that when and if this clause ever applies, the Contractor will have the right to assume and control the defense of the State for purposes of resolving the issue?

Regarding Section 9 (Liquidated Damages) of the General Conditions, can you confirm whether Liquidated Damages are included and applicable to this RFP/Contract?

Regarding Section 13 (Termination for Default) of the General Conditions, part a. indicates there is a 10 day cure period allowed. Can you confirm if the cure period can be extended to at least 30 days?
